**PROPOSALS FOR PRE-QUALIFICATION**

1. Government of Pakistan, Ministry of Interior C Narcotics Control, Headquarters Anti Narcotics Force Rawalpindi intends to pre-qualify, Automobile Workshops/ Firms/ companies for repair / maintenance, Engine work, Denting C Painting, Air Conditioning Work, Provision of Spares Parts, Tyres, Tubes C Batteries of Vehicles (LTV C HTV), Repairing / Maintenance of Motorcycles and sale of use oil, spare Parts, Old Tyres and Batteries for Financial Year 2026/2027. Bid security is mentioned against each item on EPADS.
2. Bidding will be conducted through PPRA EPADS 2.0 as per PPRA Rules 2004 36(a) alongwith terms C conditions mentioned in bidding documents.
3. Only firms/Contractors registered with PPRA on E-PADS as vendors are eligible to apply.
4. The firm providing unsubstantiated and/or incorrect information are liable to legal action and disqualification from the bidding.
5. The Authority reserves the right to reject all bids as per PPRA Rules-2004.
6. The Advertisement is also available on Anti Narcotics Force and PPRA's websites.
7. Documents required for pre-qualification of the firm/ company are as under:-
  - a. Registered with FBR (valid GST C income tax registration certificate).
  - b. Bank statement (last financial year).
  - c. Previous five years work experience details.
  - d. Detail of equipment, machinery, C labour held.
  - e. Certificate that the Automobile Workshop/ firm/ Companies has not been blacklisted ever / Certificate that there is no case/ litigation against Automobile Workshop.
  - f. Certificate of good reputation from Departments working with (if available).
  - g. Other important documents (Copy of CNIC, IBAN, Bank Account Details, Vender Opening Performa (AGPR), 5 x copies of firm's pads (with stamp), Workshop pictures and e-mail address C Mobile / WhatsApp Nos etc.
