- Tender / bids will be opened in the office of Director / Dy. Director (Civil) A/Sadr, CDA located at Room No.32, Ground Floor, A/Sadr Building, Islamabad on schedule date and time mentioned above.
- The prospective bidders are also required to submit their Bids online through E-PADS at <http://eprocure.gov.pk> on or before tender opening date & time. Original bids in accordance with the provisions of PPRA Rule 36(a) and other terms & Conditions as defined in the bidding documents.
- The prospective bidders are also required to submit an undertaking on stamp paper duly attested by notary public worth not less than Rs.50/- that the firm / contractor are neither involved in any litigation nor black listed by any government, Semi government of autonomous body in Pakistan and also undertakes that if any information or document provided is found incorrect or fictitious that firm is liable for disqualification and legal action under the law.
- CDA can reject all bids or proposals at any time prior to the acceptance of a bid or proposal and conditional bids will be rejected at the spot as per PPRA rules.
- In case of any Gazetted / Occasional Holidays, the tenders will be opened on the next working day.
