Proposals are invited from reputable Consultants (Engineering Organizations/Firms) having valid Pakistan Engineering Council (PEC) registration certificate in relevant field along with enlistment on active Tax Payer list of Federal Board of Revenue and the detail eligibility criteria mention in the RFP documents.
