2. The **FEDERAL GOVERNMENT POLYCLINIC (PGMI) ISLAMABAD** invites E-bids from eligible Bidders for procurement of goods and Services described in the bidding documents on **EPADS v2.0**.
3. **Single Stage-Two Envelope** procedure will be used by adopting **Least Cost Based Selection (LCBS)** Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority from time to time.
4. All Bids must be accompanied by a Bid Security described in Bid Security Section in Bidding Document in the form of **Pay Order, Call Deposit Receipt – CDR in the name of Executive Director FGPC**.
5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on **e-Pak Acquisition and Disposal System (EPADS) at <https://vendors.epads.gov.pk/>**.
6. The participant firms/bidders are requested to upload copies of Undertakings on judicial papers and Pay Order/CDR along with bid/s on EPADS, however Original Judicial Papers and Pay Order/ CDR (in the name of Executive Director FGPC) should be submitted in the hospital before OR on scheduled date and time of bid opening.
7. Bidder(s) are required to get themselves registered on **EPADS v2.0** on or before **Monday, July 06, 2026 10:00 AM**. E-bids will be opened using **EPADS v2.0** on the same day at **Monday, July 06, 2026 10:30 AM**. Manual submission of Bids shall not be entertained. Those vendors, who have not yet registered on the new version of **EPADS v2.0**, may register themselves on <https://vendors.epads.gov.pk/>.
