<b>TERMS &amp; CONDITIONS</b>		
1	Inspection	Motorcycles can be inspected <b>02 working days</b> before the auction date between <b>1000 to 1500 hours</b> with intimation / permission of DD (Admin), NTC HQs, Islamabad. Auction Form can be obtained from Admin Deptt, NTC HQs, Islamabad.
2	Bid	Sealed bid along with PKR. 7,800/- of offered / invoice be deposited in advance on <b>July 2<sup>nd</sup>, 2026 (Thursday) till 11:00 am</b> through Pay Order / Bank Draft in favour of DD (Admin), NTC HQs, Islamabad. Sealed bids will be opened on the same day at 11:30 am & top 03-05 bidders will be allowed to participate in the open auction bid. The highest quoted bid will be considered as successful bidder. Taxes will be charged to successful bidder as per Govt. policy.
3	Payment	Remaining amount will have to be paid through Pay Order / Bank Draft within 02 working days subject to award of work by NTC.
4	Delivery / Removal	Motorcycles sold will have to be lifted by the successful bidder at his own expenses within 02 working days after approval / award of work by NTC subject to full payment by the bidder.
5	Forfeiture	In case the highest bidder fails to deposit the total bid amount within 02 working days, security amount will be forfeited / confiscated in favour of NTC without further notice besides cancellation of bid and NTC will be at liberty to sell the Stores to any other party at its own discretion.

1. NTC employees directly or indirectly are not allowed to participate in the auction.
2. All participants must bring their original CNIC and FBR Registration Certificates with them. No person will be allowed to enter in the premises without the CNIC.
