### Nature of Work:

- Safe handling and transportation of HT / LT steel structures from TESCO store to site of work including loading, unloading, digging of pole pits, erection of poles, making of foundation for structures, curing & back filling etc according to WAPDA/ PPMC/ TESCO SDI.
- Safe handling of HT / LT Conductor and its accessories, stringing, sagging, making of distribution lines, as per WAPDA/ PPMC / TESCO SDI.
- Safe handling of 11 kv out going panels along with accessories and its installations, testing & commissioning etc as per WAPDA/ PPMC/ TESCO SDI.
- Providing earthing / stay to HT / LT structures & Transformers as per WAPDA/ PPMC/ TESCO SDI.
- The cost of testing ordered by Engineer incharge, according to the standard procedures, shall be responsibility of contractor and will be recovered from him.

### Eligibility:

This invitation for e-Bids is open to all Bidders, meeting the following requirements:

- Registration with PPRA, including the use of **E-PADS V2.0 Version**, and the Pakistan Engineering Council (PEC) renewed for the year 2025-26 for the financial categories and codes specified for each work. The bidder must demonstrate two (02) years of experience in the field of construction as per the required registration category and codes of the Pakistan Engineering Council (PEC).
- A bidder shall be a natural person, private entity or government-owned enterprise, who is active tax payer with FBR and will provide income tax returns for the last 01 year. The bidder should have an average annual turned over 25.00 million & current month balance of Rs. 3.00 million
- A bidder shall be an active / registered tax payer with KPRA, FBR, Sale Tax.
- Affidavit that the attached documents i.e PEC, FBR, NTN, CDR and Work Orders etc are genuine.
- Found fake at later stage, the firm will be held responsible for all consequences.
- Bidders must have successfully completed at least 02 Nos. of contract for construction of similar nature of work that has been successfully completed within the last 05 years. The bidder shall provide relevant original work orders /contract agreements & completion certificates etc. Bidder must have demonstrated satisfactory performance of previous completed / ongoing works from concerned XEN / SDO. **The contractor who have already running works in TESCO will have to provide satisfactory / performance certificate from concerned SDO.**

### Terms & Conditions:

National Competitive Bidding (NCB) will be conducted in accordance with **Single Stage Single Envelope** method.

- A complete set of Bidding Documents contain detailed instructions/terms & conditions and specifications, are available for registered bidders, on EPADS at (<https://ppra.gov.pk/>), as well as in the office of Executive Engineer TESCO Construction Division Peshawar.
- Tender cost/fee non-refundable @ Rs.3,000.00 (Three thousand only) shall be deposit online in **ABL bank, A/C No. 0321-0010000559360057 of XEN TESCO Construction Division Peshawar** before bid closing time in the office of TESCO Construction Division Peshawar.
- The prospective bidder shall submit 2% as Bid Security of the estimated project cost in the form of a CDR (Original sealed CDR submitted before closing time) from any scheduled bank of Pakistan, in favor of Executive Engineer TESCO Construction Division Peshawar, before bid closing time, failing which the e-bid shall be considered 'non-responsive' and rejected.
- The successful bidder will have to submit (08%) additional CDR of the estimated cost as a performance guarantee within 14 days after award of contract.
- The bidder who quoted a bid (10%) below of the engineered estimate shall also submit an additional 08% Bid Security of the estimated cost with e-bid, in the form of CDR (Original sealed CDR submitted before closing time), failing which the bid(s) shall be considered 'non-responsive' and rejected.
- All the interested Bidders are directed to apply through E-Pak Acquisition & Disposal System (**E-PADS V2.0 Version**) portal online (<https://ppra.gov.pk>) as per procedures laid down in the regulations of PPRA as per following date and time mentioned below in the office Executive Engineer TESCO Construction Division Peshawar.

- The contractor shall be responsible for ensuring compliance with the NEPRA safety code.
- The contractor who fulfill all terms & conditions from Sr. No. a to j will be eligible, if not fulfill all the above terms & conditions will be rejected.
- TESCO reserves the right to accept or reject all the e-bids as per PPRA rule 33 (1).
