- Valid registration with the Federal Board of Revenue (FBR) and listing on the Active Taxpayer List (ATL).
- Updated Pakistan Engineering Council (PEC) registration in Category C-6 for the current year
- A valid Professional Tax Certificate.
- Copy of CNIC of the owner(s).
- Original bid, bid security in hard form on due date & time
- Affidavits confirming:
 - Ownership of the firm. (on stamp paper of Rs. 200/-)
 - No blacklisting & No pending litigation. (on stamp paper of Rs. 500/-)

4. Bid security must be submitted in the form of a Pay Order / Bank Draft from any scheduled bank, drawn in favor of **“Pakistan Airports Authority”**. The Bidders must submit their bids, bid security, and mandatory documents electronically through the PPRA EPADS Web Portal (<https://eprocure.gov.pk>) before the submission deadline. The original bid, bid security and above mentioned affidavits in 3 (f), must be submitted in person to the office of the Divisional Engineer Civil-II, JIAP, on the due date and time.

5. PAA reserves all rights to accept or reject any or all the tenders as per PPRA rules.

Pay orders, bank drafts, or any other financial instruments submitted by bidders and contractors as tender cost, earnest money, bid security, or bank guarantees, if found fake or dishonored by the issuing bank or financial institution at any pre- or post-contract stage, will result in blacklisting and legal action as per the law of the land.
