Terms & Conditions

1. The period of lease is 30 years extendable for another 20 years on mutual consent and other terms & conditions as stipulated in PAA Land Lease Policy 2019.
2. Each auction participant shall bring two (02) copies of his/her CNIC and submit them, along with a auction participation fee of PKR 10,000/- (non-refundable) and the earnest money, both in the form of a Pay Order in favor of **Pakistan Airports Authority** to the Auction Committee at the venue before start of the Auction proceedings.
3. The earnest money deposited by the unsuccessful bidders shall be refunded within a period of 15 days of confirmation of the bid.
4. Only valid Master Franchises and Sub - Franchises having international brand presence are eligible to participate in Auction for Plots "**A, B, C & E**". In respect of Plot "**D**", only Pakistani Food Brands are eligible to participate in Auction Proceedings.
5. Defaulters of PAA and Blacklisted Companies are not eligible to participate in Auction proceedings.
6. The Sky View Food Promenade sites shall be leased out on "as it is, where it is" basis.
7. The highest bid shall be placed before PAA Executive Committee for approval. The same shall be accepted or rejected by the PAA Executive Committee. In case of rejection, the leasehold rights shall be put to fresh auction within 30 days or such further time as may be decided by the PAA.
