

TENDER NOTICE

1. The Pakistan Airports Authority (Pakistan Airports Authority (PAA)) has reserved Funds for the procurement planned for FY 2026-27. The Pakistan Airports Authority (Pakistan Airports Authority (PAA)) intends to apply part of the proceeds of this Fund to cover eligible payments under the contract for the **"REHABILITATION / IMPROVEMENT OF ELECTRICAL & HVAC INFRASTRUCTURE AT PAA OFFICER / STAFF MESS AT SZIAP RAHIM YAR KHAN"**.

2. The Pakistan Airports Authority (Pakistan Airports Authority (PAA)) invites sealed Bids from eligible Bidders for procurement of Works (**REHABILITATION / IMPROVEMENT OF ELECTRICAL & HVAC INFRASTRUCTURE AT PAA OFFICER / STAFF MESS AT SZIAP RAHIM YAR KHAN**) described in the bidding documents on EPADS v2.0.

3. Single Stage-One Envelope will be used by adopting Least Cost Based Selection (LCBS) Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority from time to time.

4. All Bids must be accompanied by a Bid Security amounting to Rs. 300,000/- in the form of Pay Order, Banker's Cheque, Call at Deposit, Bank Guarantee, and Demand Draft. Physical Instrument of Bid Security in the prescribed format should be reached to the under-mentioned office well before the bid submission deadline.

5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on e-Pak Acquisition and Disposal System (EPADS) at <https://vendors.epads.gov.pk/> for all the interested bidders registered on EPADS v2.0. Bidders are required to get themselves registered on EPADS v2.0 to participate in bidding process.

6. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through EPADS v2.0 on or before **Thursday, September 10, 2026 11:00 AM**. E-bids will be opened by using EPADS v2.0 on the same day at **Thursday, September 10, 2026 11:30 AM**. Only manual submission of Bids shall not be entertained. Bidders are also advised to submit a hard copy of their bids in sealed envelope to undermentioned office

7. In terms of Rule 48 of Public Procurement Rules, 2004 Grievance Redressal Committee (GRC) is notified for the subject procurement and notification copy is available on the procuring agency's website and on Authority's website at (www.ppra.org.pk).
