1. CMT & SD Golra intends to procure cloth, wire steel for hesco bag, miscellaneous cover water proof jacks, MT tools, machine tools / equipment to meet anticipated LP demands of dependent users during FY 2026-27 and invites sealed tenders from eligible bidders.
2. Tenders are invited in line with **single stage – two envelope** process as specified in PPRA Rules 2004 and any Regulations, Regulatory Guides, Procurement Guideline or Instructions issued by the Authority from time to time.
3. Bidding is open to all manufacturers, agents of manufacturers, authorized distributors, suppliers and contractor firms who can demonstrate their registration with Income Tax, Sales Tax and Excise & Taxation Departments, Active Taxpayer List (ATL) of Federal Board of Revenue (FBR) and registration with Directorate General Defence Procurement (DGDP) / Directorate General Procurement – Army (DGP-A) / any Ordnance Depots of Pakistan Army, CAF and Securities Exchange Commission of Pakistan (SECP) for supply of stores.
4. Interested bidders may inspect the tender documents available at Local Purchase Office of CMT & SD Golra on any working day during response time of tender between **0800 hours to 1600 hours** and purchase the documents at a cost of **Rs. 5,000/-** (Rupees Five Thousands) in cash which is non-refundable.
5. Sealed tenders must be dropped in tender box placed at Main Gate of CMT & SD Golra on or before **31 Aug 2026 till 1030 hours**. Sealed tenders will be **opened at CMT & SD Golra Road Rawalpindi on 31 Aug 2026 at 1100 hours** in the presence of bidders' reps who choose to attend. Late tenders/ bids will be rejected and returned unopened to respective bidders.
6. Tender should accompany **Bid Security of Rs. 500,000/-** (Rupees Five Hundred Thousands) in the form of CDR.
7. Submission of Technical Proposal, Financial Proposal, Bid Security, Bidder's Eligibility / Profile Documents in prescribed manner is mandatory. Failure to comply with instructions is liable to cause outright rejection of bid.
8. Purchaser does not pledge to accept the lowest rates. He reserves the right to accept the whole or part of the offer or completely reject the tender without explaining reason.
9. All purchases will be subject to inspection to ensure quality, quantity and standard of stores.
10. **Lab test reports for Cloth, Wire Steel For Hesco Bag and cover water proof** is mandatory from **ASID Lahore and IAS&C Karachi** and quotations without lab reports will not be entertained.
11. All bidders are bound by the Official Secret Act 1923 to ensure confidentiality of bids and purchases of stores and not share information / details of bids / contract / quantities / delivery locations with anyone not party to bid / purchase.
12. There will be no price negotiation with the lowest evaluated responsive bidders. Suppliers are therefore requested to submit their lowest and best prices of standard stores as per Army Specifications/ General Staff Requirement (GSR). Quoted rates should be inclusive of all applicable taxes and valid till **30 June 2027** and bidders will be bound to accept purchase orders for supply of stores on their quoted rates regardless of any market factors throughout country.
