The Consultant shall primarily focus on all E&S parameters of the Project to be monitored periodically, which can be derived from the Project’s E&S documents as listed in the TOR. The initial contract will cover a total of one year, renewable based on satisfactory performance and project requirements. The consultant will work with the NHA as per agreement to carry out the tasks outlined in the TOR.

The National Highway Authority (NHA) now invites eligible consultancy firms (“Consultants”) to indicate their interest in providing the Services. A Consultant will be selected in accordance with the Consultant’s Qualifications Based Selection (CQS) method set out in the Procurement Regulations.
