5. Procurement will be carried out by adopting "Single Stage Two Envelops" procedure. Separate Proposals for respective positions complete in all respects, in accordance with the instructions provided in the RFP document, in sealed envelopes should reach on or **28<sup>th</sup> July, 2026 at 1130 hours** in the office of General Manager (P&CA) NHA-HQ 28-Mauve Area, G-9/1, Islamabad and be clearly marked "*Hiring of Structural Expert for Design & Review of Bridges Structures.*"
6. The technical proposals shall be opened on the same day at **1200 hours**, whereas the financial proposals of the technically qualified Individual Consultant shall be opened after finalization of technical evaluation. Other details are provided in the RFP document against the relevant position.
