1. The National Highway Authority (NHA) intends to hire an Individual Consultant for "Consultancy Services for Hiring of Legal Counsel for PPP Projects"
2. Proposals are invited from reputable Consultants having valid membership with at least one Bar Council of Pakistan along with enlistment on Active Tax Payers List of Federal Board of Revenue and the detail eligibility criteria mentioned in the RFP document.

RFP documents can be downloaded from NHA's website www.nha.gov.pk free of cost or the same can be purchased from the office of General Manager (P&CA), NHA-HQ, Islamabad during working hours and working days on written request of Individual Consultant's letter head accompanied with pay order/demand draft amounting to Rs.1,000/- (nonrefundable) in favor of National Highway Authority.
4. Pre-Proposal Conference will be held on **21st August 2026 at 1100 hours** in the NHA Auditorium (HQ) Islamabad.
5. Procurement will be carried out by adopting "Single Stage Two Envelops" procedure. Separate Proposals for respective positions complete in all respects, in accordance with the instructions provided in the RFP document, in sealed envelopes should reach on or **3rd September, 2026 at 1130 hours** in the office of General Manager (P&CA) NHA-HQ 28-Mauve Area, G-9/1, Islamabad and be clearly marked "Consultancy Services for Hiring of Legal Counsel for PPP Projects."
6. *Individual* Consultants are required to submit their proposal strictly in accordance to Instructions to Applicants (ITA), Data Sheet of ITA and RFP Notice. Proposals must be prepared in hard book binding form to deny the possibility of addition or removal of page(s).
7. The technical proposals shall be opened on the same day at **1200 hours**, whereas the financial proposals of the technically qualified firms shall be opened after finalization of technical evaluation. Other details are provided in the RFP.
