Subject: COMPARATIVE STATEMENT FOR TENDER REGARDING SUPPLY OF FRESH AND DRY FOOD ITEMS


In compliance with the directives of the Ministry of Energy (Petroleum Division) conveyed vide letter No.1(1)/Secy/2025/Misc., dated January 16, 2026 regarding Ramzan Relief Package / expanding Corporate Social Responsibility providing ration bags to needy and deserving citizens (*Annex-A*), the following is submitted for consideration and approval:

1. Tenders were invited from reputable firms for the supply of fresh and dry food items (Ration bags) for needy and deserving citizens. The tender notice was published in leading daily newspapers and simultaneously uploaded on the PPRA website in January 2026 (*Annex-B*).
2. In response, seven firms obtained the tender documents, out of which five firms submitted their bids. The tenders were publicly opened on February 12, 2026, at the scheduled date and time, in the presence of representatives of the participating firms.
3. Details of the firms along with their quoted rates are tabulated below:

4. An amount of Rs. 50 million has been allocated under the Emergency Relief Fund for the Financial Year 2025-26. The financial powers of the Managing Director for award of commodity procurement contracts are limited to Rs. 10 million at a time (*Annex-C*).
5. The Tender Evaluation Committee assessed all bids strictly in accordance with the criteria stipulated in the tender documents. Upon evaluation, **M/s Shaheen Mohammad Zai & Brothers** was found technically qualified and has quoted lowest per-packet rate of **Rs.12,190/-** (inclusive of all taxes, transportation, and labour charges) for the supply of fresh and dry food items.
6. In view of the above, approval is solicited to award the supply contract/work order to **M/s Shaheen Mohammad Zai & Brothers** being the lowest evaluated and technically responsive bidder.
