Subject: **MINUTES OF THE MEETING OF REPAIR / PURCHASE / TECHNICAL / GREVIANCE COMMITTEE HELD ON 08.05.2026 FOR PRE-QUALIFICATION OF WORKSHOPS / VENDORS FOR REPAIR OF FURNITURE, HARDWARE AND IT EQUIPMENT ETC OF COLLECTORATE OF CUSTOMS AIRPORTS, ISLAMABAD FOR F.Y 2025-26.**


An advertisement inviting for pre-qualification for repair of Furniture, Machinery, Hardware, and IT Equipment etc of different kinds from interested workshops / vendors was uploaded on the website of the Public Procurements Regulatory Authority (PPRA), the official site of the Federal Board of Revenue, and ePADS, on 22.04.2026.


2. Sealed bids were received in office of the Chairman Procurement Committee and the same were uploaded on ePADS by 08.05.2026 till 03:00 pm. The following firms participated in the pre-qualification and their technical proposals were opened at 03:30 pm. As mentioned below:

3. The bids submitted by the above firms were opened by the committee, in presence of the representatives of above firms, for evaluation and assessment. The committee found that two participating firms at S. No. 1 & 2 have sufficient resources, staff and capabilities to carryout necessary repair & maintenance of office furniture, IT Equipment, hardware etc. of all kinds and, therefore, recommended that above mentioned firms may be pre-qualified for repair of office furniture, IT Equipment, hardware etc. of Collectorate of Customs Airports, Islamabad.

4. In view of the above, the meeting of committee was held on 08.05.2026. The purchase committee recommended that, keeping in view the requirements and available budget with Collectorate of Customs Airports, Islamabad, two firms namely: (1). M/s Zigma Enterprises, Islamabad and (2) M/s Empire Business Services, Islamabad may be pre-qualified for repair of office furniture, IT Equipment, hardware etc.during financial year 2025-26 by adhering to the conditions as laid down in the bidding Documents / PPRA Rules, observing all legal and codal formalities.
