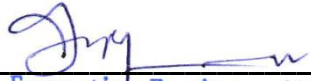

NAME OF WORK:REPAIR AND MAINTENANCE OF KPT FLAT NO. FK-35 AT KV-12
BUILDING CHINA CREEK KEAMARI.

INTRODUCTION:

1. The Resident of KPT Flat No. FK-35 at KV-12 vide application has requested for the repair & maintenance works of official KPT accommodation, which is in dilapidated condition. The accommodation was visited by AXEN / Sub Engineer (KV) and observed that the KPT official accommodation is in much dilapidated condition and needs repair to make the same in livable condition. (Photographs are placed at S.No. 1/A).
 Accordingly, AXEN (KV) has prepared an estimate amounting to Rs.999,708.00 alongwith plan, to attend the same through outsource, as the same is beyond the scope of in-house arrangements.
 It is pertinent to mention here that, no work has been done since, from last 03 years at the subject Flat.
2. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through E-PADS on 26-03-2026, KPT / MoMA & PPRA Website on 26-03-2026 and received on 16-04-2026.

RECOMMENDATIONS

The Single Evaluated Bid amounting to Rs.847,482.67 (Rupees: Eight Hundred Forty Seven Thousand Four Hundred Eighty Two & Sixty Seven Paisa Only) received in accordance under Clause PPRA Rule 36(a) from M/s. Allah Bux Kalwar which is 15.06% below the corresponding estimated cost of Rs.999,708.00 based on KPT revised schedule of rates 2023-24 is considered reasonable. Keeping in view of their past performance as mentioned in Para-2(m) M/s. Allah Bux Kalwar is considered capable for carrying out the work viz. **"REPAIR AND MAINTENANCE OF KPT FLAT NO. FK-35 AT KV-12 BUILDING CHINA CREEK KEAMARI"**.

The Committee therefore, recommends the acceptance of the Lowest Evaluated Bid amounting to Rs.847,482.67 (Rupees: Eight Hundred Forty Seven Thousand Four Hundred Eighty Two & Sixty Seven Paisa Only) received from M/s. Allah Bux Kalwar is considered reasonable for the work viz. **"REPAIR AND MAINTENANCE OF KPT FLAT NO. FK-35 AT KV-12 BUILDING CHINA CREEK KEAMARI"**.
