TERMS AND CONDITIONS

1. Tender shall be sent under sealed cover which should reach to the undersigned by 31.08.2026 at 2.00 p.m. The tender will be opened on the same day at 2.30 p.m. in the presence of the tenderers or their authorized representatives who may like to attend. The rates must also be quoted on **EPADS 2.0**, failing which bid will not be entertained. The bidding firms are required to enclose photo copy of PCP receipt regarding purchase of tender documents alongwith their sealed offers/bids. The old unserviceable machines and mixed scrap lying at PCP Press, University Road, Karachi can be inspected during office hours between 9.00 a.m. to 4.00 p.m.
2. The tender must be accompanied with Call Deposit/Pay Order/Demand Draft of Rs.500,000/- (Rupees five lac only) as earnest/security money in favor of the Printing Corporation of Pakistan, Islamabad which shall be refunded on successful completion of the job.
3. The offer should be valid for 90 working days from the date of opening of tender.
4. The rates may be given on the basis of “AS IS WHERE IS” for old unserviceable machines and mixed scrap per Kg. **exclusive of taxes.**
5. The successful Contractor shall be liable to pay all taxes as announced by the Government of Pakistan from time to time in addition to the sale price before lifting the old unserviceable machines and mixed scrap and get separate receipt/certificate from PCP for deposit of tax for his own record.
6. The payment of old unserviceable machines and mixed scrap duly weighted including taxes shall be made in advance before lifting the same through cash payment/Bank Deposit in PCP Account.
7. Conditional, incomplete, overwritten and ambiguous tender shall not be accepted.
8. In case of default on the part of the successful bidder/contractor in carrying out of terms and conditions of this tender after its execution or prior to execution or using delaying tactics causing loss to PCP or any violation, in whole or part thereof, willfully and

intentionally or subletting of contract, the security deposit shall be liable to be forfeiture in favour of PCP.

9. The Corporation reserves the right to reject all or any tender in accordance with PPRA Rules 33.
10. The Corporation itself reserves the right to award the contract to more than one firm/party for any item. However, preference shall be given to the highest bidder.
11. The Contractor shall lift the available old unserviceable machines and mixed scrap within 60 working days soon after signing of contract agreement, extendable with mutual consent of both the parties with the prior approval of the Managing Director, PCP.
12. In case of failure to lift all the old unserviceable machines and mixed scrap within 60 working days, the penalty @ 0.5 percent per day of the value of remaining old unserviceable machines and mixed scrap will be imposed on the firm/party which will be deducted from the security money of the firm/party.
13. The Security bid of the successful bidder will be retained while in the case of others, it will be refunded to them.
14. In case of any dispute in interpretation of the terms and conditions of this tender the Managing Director, PCP shall be the sole arbitrator and his/her decision shall be the final and binding upon all concerned.
