TENDER NOTICE

A Federal Government Organization (based at Lahore) invites sealed bids for the Financial Year **2026-2027** from GST registered firms in connection with purchase of Stationery, Other Store Items and Toners & Drum units on the following terms and conditions:

- a. Earnest money (**CDR**) in shape of **Demand Draft** in favor of Drawing and Disbursing Officer amounting to **3%** of the total tender should be enclosed with the tender as a security deposit. Earnest money of successful bidder would be retained as security deposit.
- b. In case, the firm will provide substandard articles during the contract period, the said amount would be deducted from the security deposit. Legal action will be initiated if the firm will provide substandard articles.
- c. An undertaking is necessary to be enclosed with the tender stating that all the rates of their articles relate to the best quality and the firm has never been blacklisted.
- d. The quoted rates should include GST and all other taxes would be applicable till **30th June 2027**. Organization can purchase items on monthly, quarterly, annually basis or as per requirements during the Financial Year **2026-2027**. The firm must provide samples of the articles mentioned in each lot at its own expense to the office on short notice.
- e. The firms are required to enclose their GST Number, Registration Certificate, Vendor Number, National Tax Number, and Professional Tax with the tender.
- f. **Single Stage-One Envelope** will be used by adopting Least Cost Based Selection (**LCBS**) Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority from time to time.
- g. **E-Bidding** documents, containing detailed terms & conditions, specifications and requirements etc. are available on e-Pak Acquisition and Disposal System (**EPADS**) at <https://epads.gov.pk/opportunities/federal/procurements/87964> for all the interested bidders registered on **EPADS v2.0**.
- h. Duly completed tenders/bids should reach Incharge Admn Branch, 94-Upper Mall, Lahore on **02.09.2026**, before **1200** hours which will be opened on the same day at **1230** hours in presence of respective bidders/ representatives of the bidders.
- i. The e-bids, prepared in accordance with the instructions in the e-Bidding Documents, must be submitted through EPADS v2.0 on or before **Wednesday, September 2, 2026 12:00 PM**. E-bids will be opened using EPADS v2.0 on the same day at Wednesday, September 2, 2026 **12:30 PM**.
- j. The bidders should quote rates of all items as mentioned in each lot. Quantities mentioned in all lots may vary according to requirement of the office.

PROCUREMENT ADVERTISEMENTS

1. Methods of advertisement

- i. Procurements over one hundred thousand rupees and up to the limit of two million rupees shall be advertised on the Authority's website in the manner and format specified by regulation by the Authority from time to time. These procurement opportunities may also be advertised in print media, if deemed necessary by the procuring agency:
- ii. Provided that the lower financial limit for advertisement on Authority's website for open competitive bidding shall be the prescribed financial limit for request for quotations under clause (b) of rule 42.
- iii. All procurement opportunities over two million rupees should be advertised on the Authority's website as well as in other print media or newspapers having wide circulation. The advertisement in the newspapers shall principally appear in at least two national dailies, one in English and the other in Urdu.
- iv. In cases where the procuring agency has its own website it may also post all advertisements concerning procurement on that website as well.
- v. A procuring agency utilizing electronic media shall ensure that the information posted on the website is complete for the purposes for which it has been posted, and such information shall remain available on that website until the closing date for the submission of bids.

2. Response time:

- i. The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice. All advertisements or notices shall expressly mention the response time allowed for that particular procurement along with the information for collection of bid documents which shall be issued till a given date, allowing sufficient time to complete and submit the bid by the closing date.
- ii. The response time shall be calculated from the date of first publication of the advertisement in a newspaper or posting on the web site, as the case may be.
- iii. In situations where publication of such advertisements or notices has occurred in both electronic and print media, the response time shall be calculated from the day of its first publication in the newspapers.
