- Rates shall be written in figures and words in separate columns. In case of conflict in figures and words, the rate quoted in words shall prevail.

- Tender will not be issued or accepted by Post/ Courier/ Telegraphic means.
- Tender Evaluation Committee reserves the right to demand the analysis of quoted rates to check their reasonability and workability.
