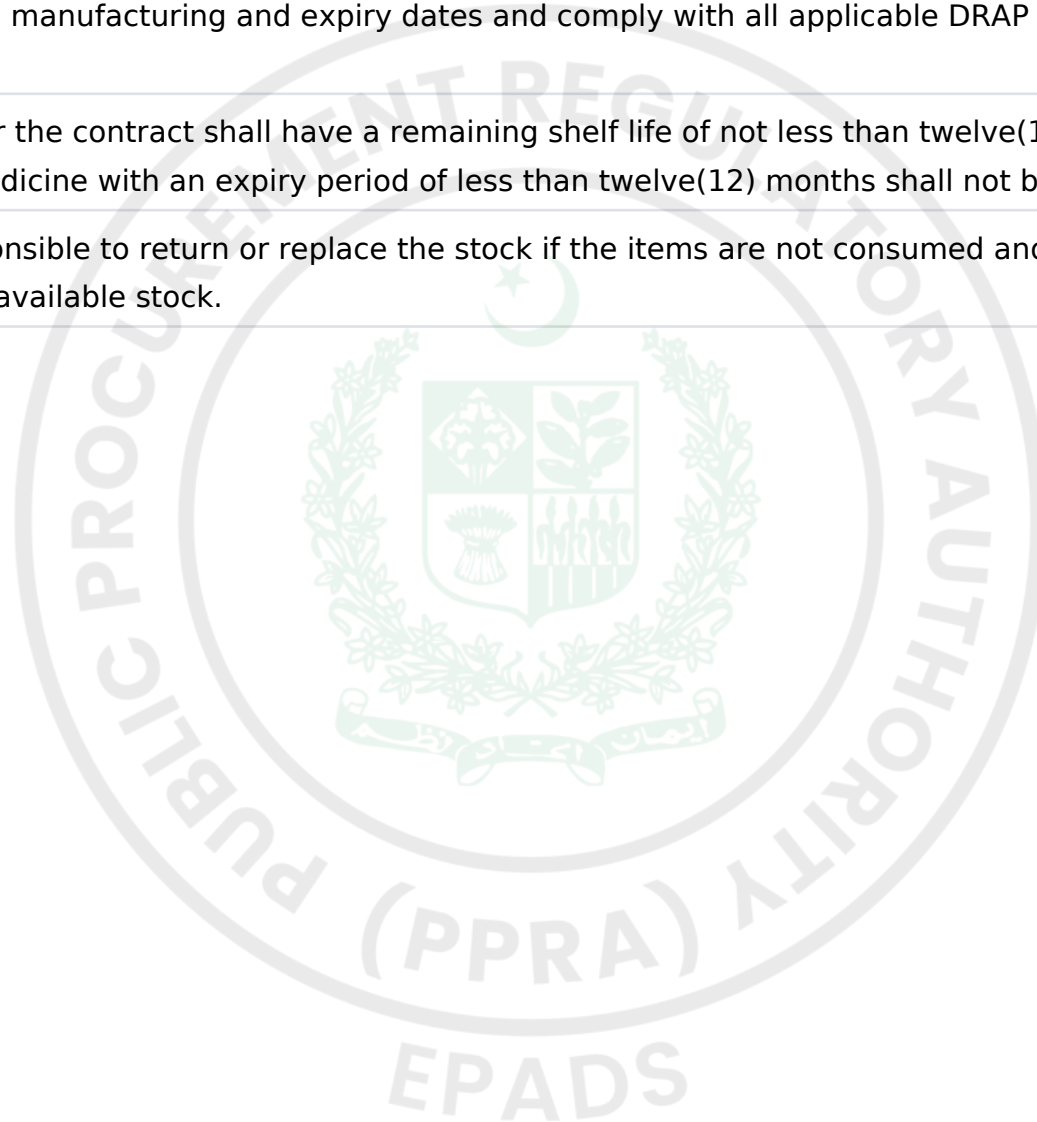

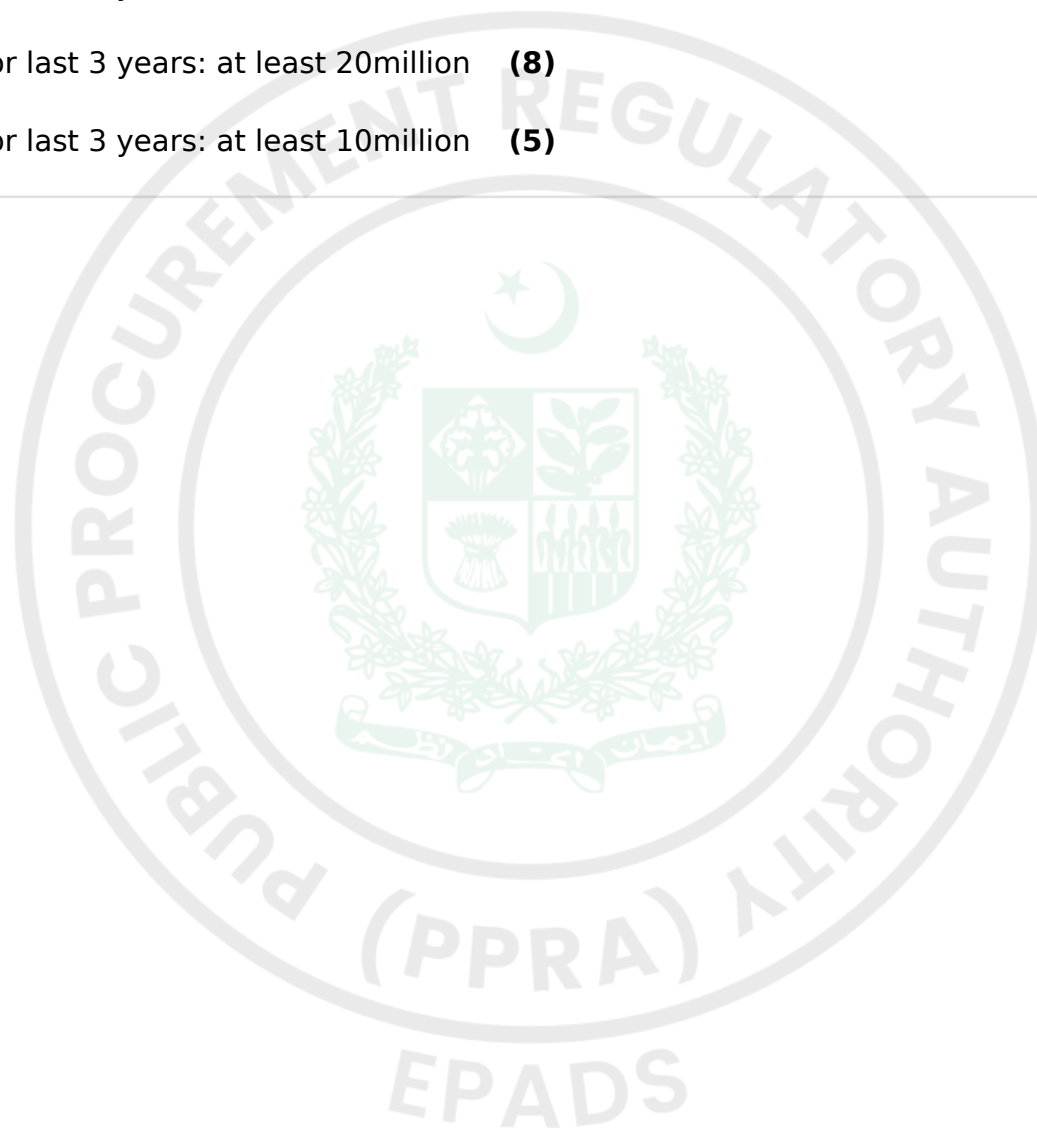

## General Conditions of Contract

## A. General

### 1. Definitions

1.1 Unless the context otherwise requires, the following terms whenever used in this Contract shall have the same meaning and shall be interpreted as indicated

- a. "Applicable Law" means the laws and any other instruments having the force of law in the Government's Country, or in such other country as may be specified in the Special Conditions of the Contract (SC), as they may be issued and in force from time to time;
- b. "Procuring Agency" means:-
  - a. any Ministry, Division, Department or any Office of the Government;
  - b. any authority, corporation, body or organization established by or under a Law or which is owned or controlled by the Government;
- c. "The Contract" means an agreement enforceable by law;
- d. "The Contract Price" means the price payable to the Bidder under the Contract for the full and proper performance of its contractual obligations;
- e. "Ancillary Services" means those services ancillary to the provision of Goods, such as transportation and insurance, and any other incidental services, such as installation, commissioning, provision of technical assistance, training, and other such obligations of the Bidder covered under the Contract;
- f. "GCC" means the General Conditions of Contract contained in this section;
- g. "SCC" means the Special Conditions of Contract by which the GCC may be amended or supplemented;
- h. "Day" means calendar day unless indicated otherwise.
- i. "Effective Date" means the date on which this Contract comes into force and effect.
- j. "The Bidder" means the individual or corporate body whose Bids to provide the Goods has been accepted by the Procuring Agency;
- k. "The Project Site," where applicable, means the place or places named in Bids Data Sheet and technical Specifications;
- l. "Government" means the Government of Pakistan;
- m. "Subcontractor" means any entity to which the Bidder subcontracts any part of the Goods.
- n. "Service" means any object of procurement other than goods or works;
- o. "Party" means the Procuring Agency or the Bidder, as the case may be, and "Parties" means both of them;
- p. "Foreign Currency" means any currency other than the currency of the country of the Procuring Agency;

q. "Completion Date" means the date of completion of the contract by the Bidder as certified by the Procuring Agency;

r. "In Writing" means communicated in written form with proof of receipt;

s. "Local Currency" means the currency of Pakistan;

## **2. Application and Interpretation**

2.1 These General Conditions shall apply to the extent that they are not superseded by provisions of other parts of the Contract.

2.2 In interpreting these Conditions of Contract headings and marginal notes are used for convenience only and shall not affect their interpretations unless specifically stated; references to singular include the plural and vice versa; and masculine include the feminine. Words have their ordinary meaning under the language of the Contract unless specifically defined.

## **3. Applicable Law**

3.1 The contract shall be governed and interpreted in accordance with the laws of Pakistan, unless otherwise specified in SCC.

## **4. Governing Language**

4.1 The Contract as well as all correspondence and documents relating to the Contract exchanged between the Bidder and the Procuring Agency, shall be written in the **English language** unless otherwise stated in the SCC. Supporting documents and printed literature that are part of the Contract may be in another language provided these are accompanied by an accurate translation of the relevant passages in English, in which case, for purposes of interpretation of the Contract, this translation shall govern.

## **5. Notices**

5.1 Any notice, request, or consent made pursuant to this Contract shall be in writing and shall be deemed to have been made when delivered in person to an authorized representative of the Party to whom the communication is addressed, or when sent by registered mail, telex, telegram, or facsimile to such Party at the address specified in the SCC.

## **6. Delivery/Location**

6.1 The Goods shall be delivered to such locations as the Procuring Agency may approve and as specified in SCC.

## **7. Authorized Representatives / Authority of Member in charge**

7.1 Any action required or permitted to be taken, and any document required or permitted to be executed, under this Contract by the Procuring Agency or the Bidder may be taken or executed by the officials specified in the SCC.

# **B. Commencement, Completion, Modification, and Termination of Contract**

## **8. Effectiveness of Contract**

8.1 This Contract shall come into effect on the date the Contract is signed by both parties and such other later date as may be stated in the SCC.

## **9. Commencement of Services**

9.1 The Bidder shall confirm availability of Key Experts and begin carrying out the Services not later than the number of days after the Effective Date specified in the SCC.

## **10. Program**

10.1 Before commencement of the Services, the Bidder shall submit to the Procuring Agency for approval a Program showing the general methods, arrangements, order and timing for all activities. The Services shall be carried out in accordance with the approved Program as updated.

## **11. Starting Date/Expiration Date**

11.1 The Bidder shall start carrying out the Services Five (05) days after the date the Contract becomes effective, or at such other date as may be specified in the SCC.

11.2 Unless terminated earlier pursuant to Clause **GCC 15** hereof, this Contract shall expire at the end of such time period after the Effective Date as specified in the SCC.

## **12. Entire Agreement**

12.1 This Contract contains all covenants, stipulations and provisions agreed by the Parties. No agent or representative of either Party has authority to make, and the Parties shall not be bound by or be liable for, any statement, representation, promise or agreement not set forth herein.

## **13. Modification**

13.1 Any modification or variation of the terms and conditions of this Contract, including any modification or variation of the scope of the Services, may only be made by written agreement between the Parties. However, each Party shall give due consideration to any Bids for modification or variation made by the other Party.

13.2 In cases of any modifications or variations, the prior written consent of the Procuring Agency is required.

## **14. Force Majeure**

### **14.1 Definition**

For the purposes of this Contract, “Force Majeure” means an event which is beyond the reasonable control of a Party and which makes a Party’s performance of its obligations under the Contract impossible or so impractical as to be considered impossible under the circumstances.

### **14.2 No Breach of Contract**

The failure of a Party to fulfill any of its obligations under the contract shall not be considered to be a breach of, or default under, this Contract in so far as such inability arises from an event of Force Majeure, provided that the Party affected by such an event (a) has taken all reasonable precautions, due care and reasonable alternative measures in order to carry out the terms and conditions of this Contract, and (b) has informed the other Party as soon as possible about the occurrence of such an event.

### **14.3 Extension of Time**

Any period within which a Party shall, pursuant to this Contract, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result

of Force Majeure.

#### **14.4 Payments**

During the period of their inability to perform the Services as a result of an event of Force Majeure, the Bidder shall be entitled to continue to be paid under the terms of this Contract, as well as to be reimbursed for additional costs reasonably and necessarily incurred by them during such period for the purposes of the Services and in reactivating the Service after the end of such period.

### **15. Termination**

#### **15.1 By the Procuring Agency**

The Procuring Agency may terminate this Contract in case of the occurrence of any of the events specified in paragraphs (a) through (e) of this Clause. In such an occurrence the Procuring Agency shall give at least thirty (30) calendar days' written notice of termination to the Bidder in case of the events referred to in (a) through (d); at least sixty (60) calendar days' written notice in case of the event referred to in (e);

- a. If the Bidder fails to remedy a failure in the performance of its obligations hereunder, as specified in a notice of suspension;
- b. If the Bidder becomes (or, if the Bidder consists of more than one entity, if any of its members becomes) insolvent or bankrupt or enter into any agreements with their creditors for relief of debt or take advantage of any law for the benefit of debtors or go into liquidation or receivership whether compulsory or voluntary;
- c. If the Bidder fails to comply with any final decision reached as a result of arbitration proceedings;
- d. If, as the result of Force Majeure, the Bidder is unable to perform a material portion of the Services for a period of not less than sixty (60) calendar days;
- e. If the Procuring Agency, in its sole discretion and for any reason whatsoever, decides to terminate this Contract;

#### **15.2 By the Bidder**

The Bidder may terminate this Contract, by not less than thirty (30) calendar days' written notice to the Procuring Agency, in case of the occurrence of any of the events specified in paragraphs (a) through (d) of this Clause.

- a. If the Procuring Agency fails to pay any money due to the Bidder pursuant to this Contract and not subject to dispute within forty-five (45) calendar days after receiving written notice from the Bidder that such payment is overdue.
- b. If, as the result of Force Majeure, the Bidder is unable to perform a material portion of the Services for a period of not less than sixty (60) calendar days.
- c. If the Procuring Agency fails to comply with any final decision reached as a result of arbitration.
- d. If the Procuring Agency is in material breach of its obligations pursuant to this Contract and has not remedied the same within forty-five (45) days (or such longer period as the Bidder may have subsequently approved in writing) following the receipt by the Procuring Agency of the Bidder's notice specifying such breach.

## **C. Obligations of the Bidder**

## **16. General**

### **16.1 Standard of Performance**

1. The Bidder shall deliver the product and carry out the Services with all due diligence, efficiency and economy, in accordance with generally accepted professional standards and practices, and shall observe sound management practices, and employ appropriate technology and safe and effective equipment, machinery, materials and methods. The Bidder shall always act, in respect of any matter relating to this Contract or to the Services, as a faithful adviser to the Procuring Agency, and shall at all times support and safeguard the Procuring Agency's legitimate interests in any dealings with the third parties.

### **16.2 Law Applicable to Goods**

The Bidder shall deliver the goods in accordance with the Contract and in accordance with the Law of Pakistan and shall take all practicable steps to ensure that any of its Experts and Sub-Bidders, comply with the Applicable Law.

## **17. Conflict of Interests**

### **17.1 Bidder Not to Benefit from Commissions and Discounts.**

The remuneration of the Bidder shall constitute the Bidder's sole remuneration in connection with this Contract or the Services, and the Bidder shall not accept for their own benefit any trade commission, discount, or similar payment in connection with activities pursuant to this Contract or to the Services or in the discharge of their obligations under the Contract, and the Bidder shall use their best efforts to ensure that the Personnel, any Subcontractors, and agents of either of them similarly shall not receive any such additional remuneration.

### **17.2 Bidder and Affiliates Not to be Otherwise Interested in Project**

The Bidder agree that, during the term of this Contract and after its termination, the Bidder and its affiliates, as well as any Subcontractor and any of its affiliates, shall be disqualified from providing Goods for any project resulting from or closely related to the Services.

### **17.3 Prohibition of Conflicting Activities**

Neither the Bidder nor its Subcontractors nor the Personnel shall engage, either directly or indirectly, in any of the following activities:

- a. during the term of this Contract, any business or professional activities in the Government's country which would conflict with the activities assigned to them under this Contract;
- b. during the term of this Contract, neither the Bidder nor their Subcontractors shall hire public employees in active duty or on any type of leave, to perform any activity under this Contract;

## **18. Confidentiality**

18.1 Except with the prior written consent of the Procuring Agency, the Bidder and the Experts shall not at any time communicate to any person or entity any confidential information acquired in the course of the contract.

## **19. Insurance to be Taken Out by the Bidder**

19.1 The Bidder(a) shall take out and maintain, and shall cause any Subcontractors to take out and maintain, at its (or the Subcontractors', as the case may be) own cost but on terms and conditions approved by the Procuring Agency, insurance against the risks, loss or damage, and for the coverage, as shall be specified in the SCC; and (b) at the Procuring Agency's request, shall provide evidence to the Procuring Agency showing that such insurance has been taken out and maintained and that the current premiums have been paid.

## **20. Bidder's Actions Requiring Procuring Agency's Prior Approval**

20.1 The Bidder shall obtain the Procuring Agency's prior approval in writing before taking any of the following actions:

- (a) appointing such members of the Personnel not provided by the Bidder;
- (b) changing the Program of activities; and
- (c) any other action that may be specified in the SCC.

## **21. Reporting Obligations**

21.1 The Bidder shall submit to the Procuring Agency the reports and documents in the numbers, and within the periods as prescribed by the Procuring Agency.

## **22. Liquidated Damages**

22.1 If the Supplier fails to deliver any or all of the Goods or to perform the Services within the period(s) specified in the Contract, the Procuring Agency shall, without prejudice to its other remedies under the Contract, deduct from the Contract Price, as liquidated damages, a sum equivalent to the percentage specified in SCC of the delivered price of the delayed Goods or unperformed Services for each week or part thereof of delay until actual delivery or performance, up to a maximum deduction of the performance security (or guarantee) specified in SCC. Once the said maximum is reached, the Procuring Agency may consider termination of the Contract pursuant to **GCC Clause 15**.

### **22.2 Correction for Over-payment**

If the Intended Completion Date is extended after liquidated damages have been paid, the Procuring Agency shall correct any overpayment of liquidated damages by the Bidder by adjusting the next payment certificate. The Bidder shall be paid interest on the overpayment, calculated from the date of payment to the date of repayment, at the rates specified in SCC.

### **22.3 Lack of performance penalty**

If the Bidder has not corrected a Defect within the time specified in the Procuring Agency's notice, a penalty for Lack of performance will be paid by the Bidder. The amount to be paid will be calculated as a percentage of the cost of having the Defect corrected, assessed as specified in the SCC.

## **25. Sustainable Procurement**

## **D. Bidder's Personnel**

### **26. Description of Personnel**

26.1 The titles, agreed job descriptions, minimum qualifications, and estimated periods of engagement in the carrying out of the Services of the Bidder's Key Personnel. The Key Personnel listed by title as well as by name are hereby approved by the Procuring Agency.

### **27. Removal and/or Replacement of Personnel**

27.1 Except as the Procuring Agency may otherwise agree, no changes shall be made in the Key Personnel. If, for any reason beyond the reasonable control of the Bidder, it becomes necessary to replace any of the Key Personnel, the Bidder shall provide as a replacement a person of equivalent or better qualifications.

27.2 If the Procuring Agency finds that any of the Personnel have (i) committed serious misconduct or have been charged with having committed a criminal action, or (ii) have reasonable cause to be dissatisfied with the performance of any of the Personnel, then the Bidder shall, at the Procuring Agency's written request specifying the grounds thereof, provide as a replacement a person with qualifications and experience acceptable to the Procuring Agency.

27.3 The Bidder shall have no claim for additional costs arising out of or incidental to any removal and/or replacement of Personnel.

29.1 If, after the date of this Contract, there is any change in the Applicable Law with respect to taxes and duties which increases or decreases the cost of the related Services rendered by the Bidder, then the remuneration and reimbursable expenses otherwise payable to the Bidder under this Contract shall be increased or decreased accordingly by agreement between the Parties, and corresponding adjustments shall be made to the amounts referred in the SCC.

### **30. Services and Facilities**

30.1 The Procuring Agency shall make available to the Bidder and the Experts, for the purposes of the Services and free of any charge, the services, facilities and property described , at the times and in the manner specified in the SCC or terms of reference.

30.2 In case that such services, facilities and property shall not be made available to the Bidder, the Parties shall agree on (i) any time extension that it may be appropriate to grant to the Bidder for the performance of the Services, (ii) the manner in which the Bidder shall procure any such services, facilities and property from other sources, and (iii) the additional payments, if any, to be made to the Bidder as a result thereof.

## **F. Payments to the Bidder**

### **34. Identifying Defects**

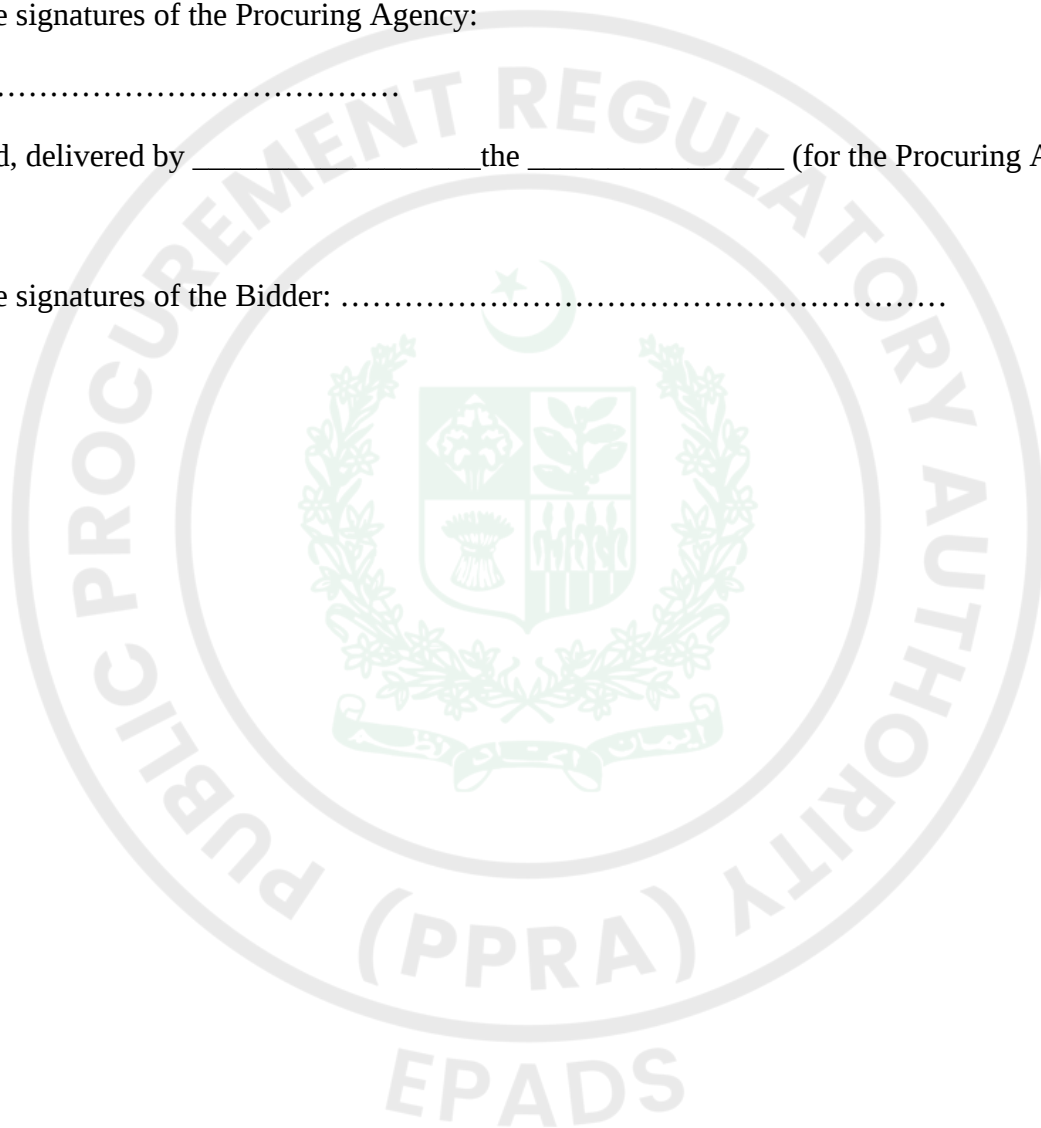

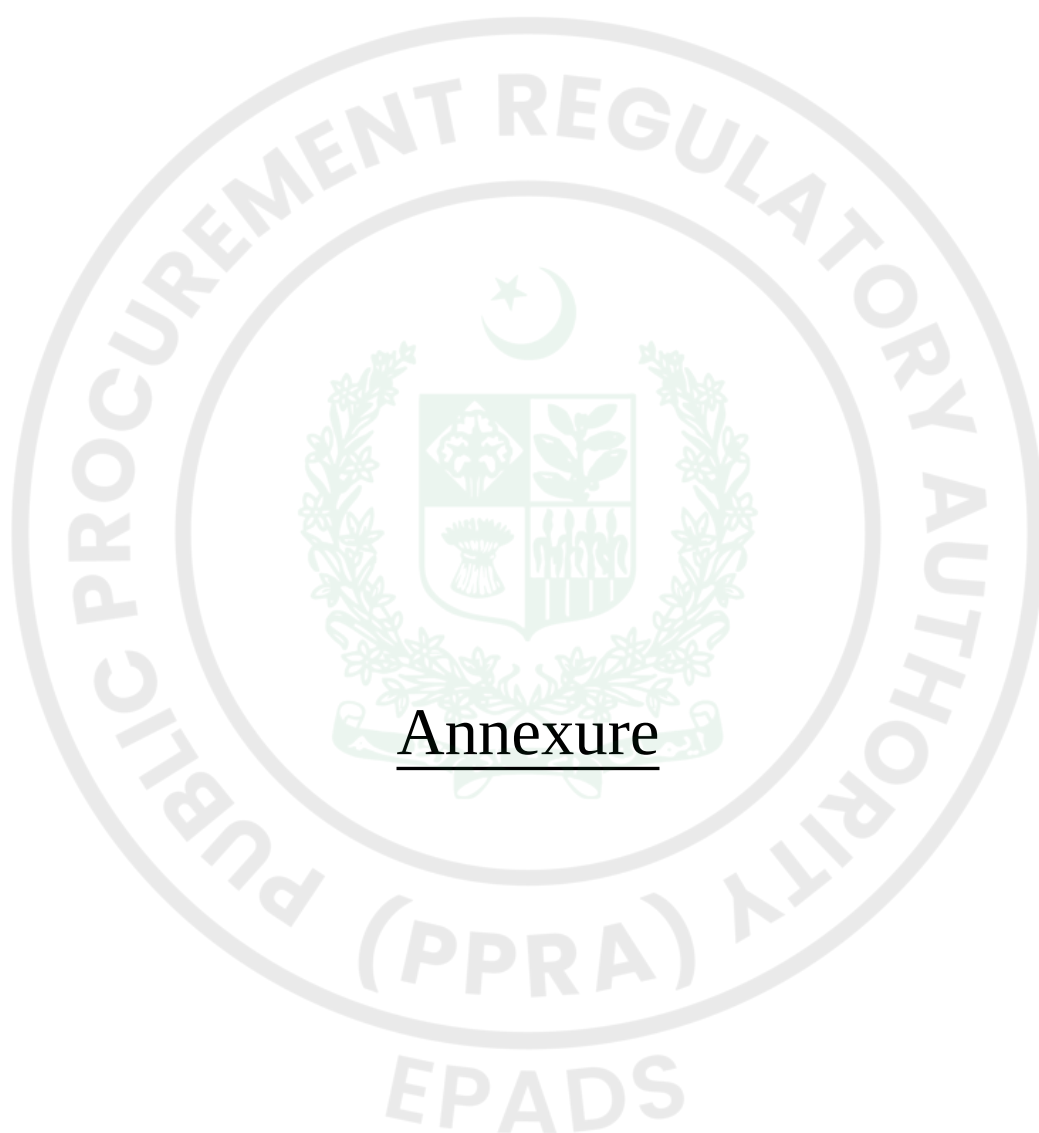

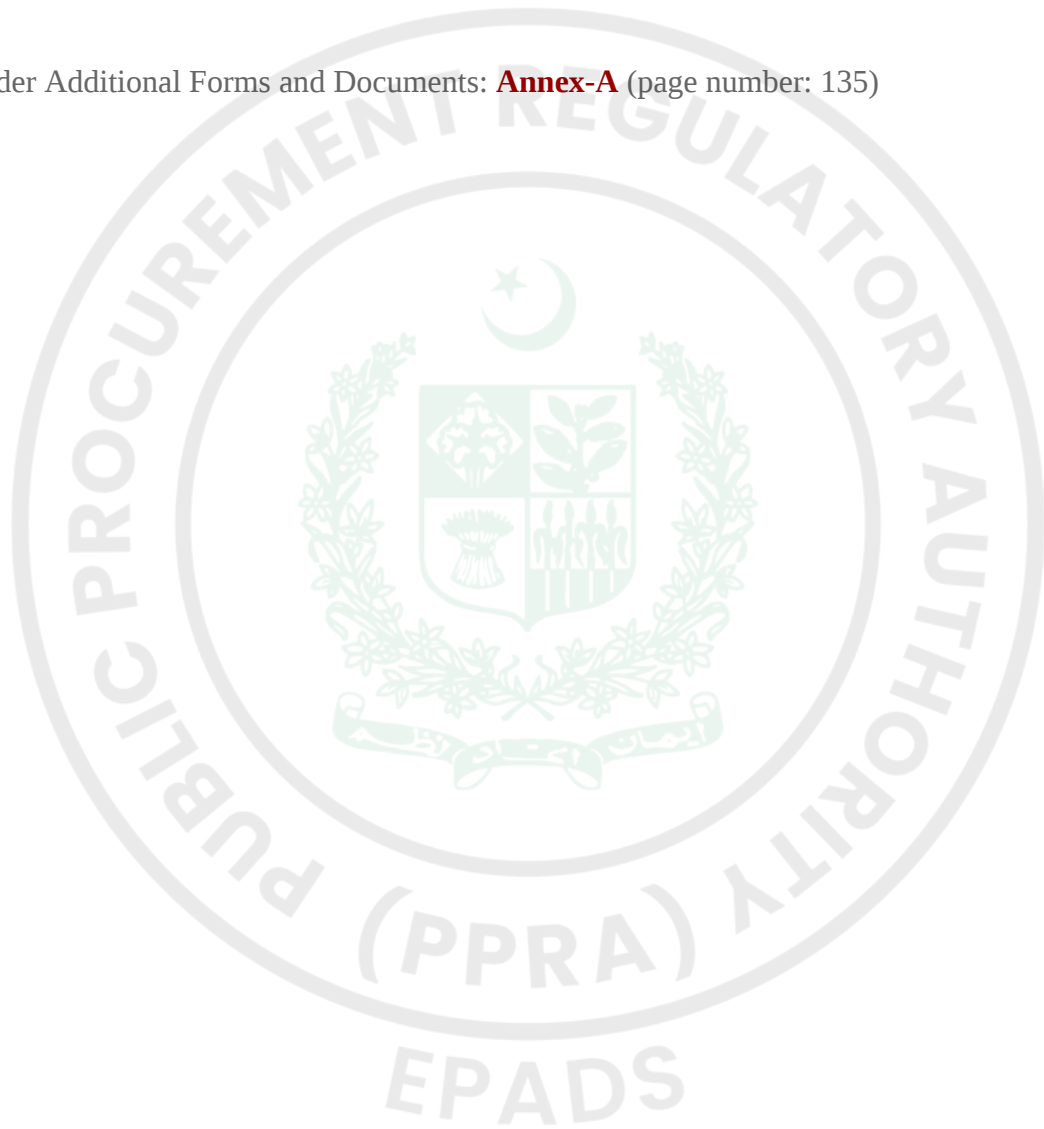

## SECTION II - INSTRUCTIONS TO BIDDERS

### 1. Scope of Bid

The Procuring Agency intends to procure the goods described in the Schedule of Requirements. The successful bidder shall supply, deliver and, where applicable, install, commission, demonstrate or provide training for the goods in accordance with the Contract.

### 2. Source of Funds

The procurement shall be financed from the relevant approved budget head for the Financial Year 2026-2027, subject to availability of funds and financial sanction.

### 3. Eligible Bidders

A bidder may be a legally constituted manufacturer, importer, authorized distributor, dealer or supplier. The bidder shall possess all registrations, licences and authorizations applicable to the offered lot. Joint ventures shall be permitted only if expressly allowed in the Bid Data Sheet.

### 4. Eligible Goods

All goods shall originate from eligible sources and shall comply with applicable Pakistani laws, DRAP requirements, medical-device rules, standards, specifications and labelling/packing requirements.

### 5. Cost of Bidding

The bidder shall bear all costs associated with preparation and submission of its bid. The Procuring Agency shall not be responsible for such costs.

### 6. Clarification and Amendment

Clarification requests shall be submitted through E-PADS within the time stated in the Bid Data Sheet. Any amendment or addendum shall be issued through E-PADS and shall form part of the bidding document.

### 7. Language of Bid

The bid and all correspondence shall be in English. Supporting documents in another language shall be accompanied by an accurate English translation.

### 8. Documents Comprising the Technical Proposal

The Technical Proposal shall contain the Bid Submission Form without prices, eligibility documents, technical compliance schedules, manufacturer authorizations, catalogues, licences, experience evidence, delivery plan, quality-assurance information, sample commitments and all documents required by Sections V and VI.

### 9. Documents Comprising the Financial Proposal

The Financial Proposal shall contain the Price Schedule for each lot, inclusive of all taxes, duties, freight, insurance, loading, unloading and delivery charges, unless stated otherwise.

### 10. Bid Prices

Prices shall be quoted item-wise and lot-wise in Pakistani Rupees. Rates shall remain firm during bid validity and the contract period unless price adjustment is expressly allowed in the Special Conditions.

### 11. Bid Security

Bid Security shall be 2% of the estimated cost of each lot bid for, in the form stated in the Bid Data Sheet, valid for at least 28 days beyond bid validity. A scanned copy shall be uploaded and the original submitted before technical bid opening.

### 12. Bid Validity

The Technical and Financial Proposals shall be uploaded separately in the designated E-PADS fields. Price information shall not appear in the Technical Proposal.

**15. Deadline and Late Bids**

Bids must be submitted before the deadline. E-PADS shall not accept late bids.

**16. Opening of Technical Proposals**

Technical Proposals shall be opened electronically at the stated date and time. Financial Proposals shall remain unopened until completion and approval of technical evaluation.

**17. Confidentiality**

Information relating to examination, clarification, evaluation and comparison of bids shall not be disclosed except as required by law and procurement rules.

**18. Clarification of Bids**

The Procuring Agency may seek written clarification that does not change the substance or price of the bid. No amendment to the Technical Proposal shall be permitted during technical evaluation.

**19. Preliminary Examination**

The Procuring Agency shall verify completeness, signatures, Bid Security, legal eligibility, required licences and material responsiveness.

**20. Technical Evaluation**

Technical Proposals shall be evaluated without reference to price using the mandatory criteria and marking criteria disclosed in Section VI.

**21. Opening and Evaluation of Financial Proposals**

Financial Proposals of technically responsive bidders shall be opened through E-PADS. Arithmetical corrections, taxes, discounts and item/lot totals shall be treated as specified in Section VII.

**22. Post-Qualification**

The Procuring Agency may verify documents, inspect premises, confirm authorizations, check performance references, request samples and verify financial or technical capacity before award.

**23. Award**

Award shall be made lot-wise to the most advantageous bid that is substantially responsive and whose bidder is qualified to perform the Contract.

**24. Right to Reject**

The Procuring Agency may reject all bids prior to acceptance in accordance with applicable PPRA Rules.

**25. Performance Security**

The successful bidder shall furnish Performance Security as stated in the Bid Data Sheet and Special Conditions.

**26. Integrity and Prohibited Practices**

Bidders shall observe the highest ethical standards and shall not engage in corrupt, fraudulent, collusive, coercive or obstructive practices.

**27. Grievance Redressal**

Complaints shall be filed before the notified Grievance Redressal Committee in the manner and within the period prescribed under applicable rules and regulations.

## 28. Blacklisting

A bidder or contractor may be proceeded against for blacklisting or debarment in accordance with law, after due process.

- Only Financial Proposals of technically qualified bidders shall be opened.
- Financial evaluation shall be conducted on the basis selected and disclosed before publication: (a) complete-lot total; or (b) item-wise lowest evaluated price. The selected method shall be stated clearly in the Bid Data Sheet and Schedule of Requirements.

**SECTION VIII - GENERAL CONDITIONS OF CONTRACT****1. Definitions**

Terms such as Contract, Purchaser, Supplier, Goods, Delivery, Day and Contract Price shall have the meanings assigned in the Contract.

**2. Contract Documents**

All documents forming the Contract shall be mutually explanatory. The order of precedence shall be: Contract Agreement, Letter of Acceptance/Supply Order, Special Conditions, General Conditions, Technical Specifications, Price Schedule and accepted bid.

**3. Governing Law**

The Contract shall be governed by the laws of the Islamic Republic of Pakistan.

**4. Notices**

Notices shall be in writing and delivered through the approved physical or electronic addresses.

**5. Performance Security**

The Supplier shall furnish the required Performance Security within the stipulated period and maintain it until completion of obligations.

**6. Inspections and Tests**

The Purchaser may inspect and test goods before and after delivery. Inspection shall not relieve the Supplier of warranty or compliance obligations.

**7. Packing and Documents**

Goods shall be packed to prevent damage and accompanied by invoices, delivery challans, batch/lot data, certificates and other required documents.

**8. Delivery**

Delivery shall be completed within the period stated in each Supply Order. Time shall be of the essence.

**9. Rejection and Replacement**

Non-conforming goods shall be removed and replaced at the Supplier's cost within the prescribed period.

**10. Warranty**

The Supplier warrants that goods are genuine, new, fit for intended use and conform to specifications. Equipment warranties shall be as stated in the Special Conditions.

Upon default, the Purchaser may procure substitute goods at the Supplier's risk and cost, after notice and in accordance with the Contract.

## 16. Termination for Default

The Purchaser may terminate the Contract for failure to deliver, material breach, false representation or prohibited practice.

## 17. Termination for Convenience

Where legally permissible, the Purchaser may terminate for convenience on written notice and pay for accepted goods and reasonable documented commitments.

## 18. Force Majeure

A party affected by an unforeseeable event beyond reasonable control shall promptly notify the other party and mitigate its effects.

## 19. Assignment and Subcontracting

The Supplier shall not assign or subcontract material obligations without prior written approval.

## 20. Confidentiality

Confidential information shall not be disclosed except as required for performance or by law.

## 21. Dispute Resolution

Disputes shall first be resolved amicably and thereafter through the mechanism stated in the Special Conditions, without limiting statutory procurement remedies.

## 22. Taxes

The Supplier shall be responsible for applicable taxes, duties and statutory obligations.
