5. Firms / Contractors not registered with Pakistan Engineering Council (Renewal of Registration for the year 2020-2021 will not be considered for issuance of tender documents.

Contractors **NOT BORNE** on MES approved list of contractors or **THOSE SUSPENDED** from the approved list MES contractors due to non-depositing enhanced amount of standing security will deposit earnest money equal to 2% of the estimated cost of bid in the form of FDR/ CDR etc, duly pledged in the name of CMES (Navy) COMLOG Karachi. This amount is refundable; if the contractors are not pre-qualified of they do not secure the tender / contract.
