The firms / contractors are required to submit separate applications against each contract to the office of A/GM Civil Maintenance POF Sanjwal Cantt upto **29-07-2026** along-with following information and documents will be considered for prequalification in the light of PPRA Rule 15(2) of 2004:-

- Name of the firm along with contact no, Postal address and E-mail address (Active).
- Attested copies of valid Active Tax payer list (ATL) of FBR for Income Tax and Sales Tax (active tax payer showing status 100%).
- Attested copies of valid Professional taxes certificate.
- Attested copies of valid registration with Pakistan Engineering Council in relevant field.
- An affidavit that the firm has never been black listed by any department.
- Relevant experience and past performance in similar nature of works completed satisfactorily in last financial year.
- Capabilities with respect to list of personnel, equipment and machinery owned.
- Financial Position Bank Statement of last two financial years.
- Appropriate managerial capability i.e organizational structure.
- Partnership deed, article of association or registration of firm certificate.

3. Firms / contractors who have been pre-qualified shall be entitled to participate in the bid proceeding. Qualified contractors / firms will be informed through contact no, Postal address or E-mail up to **06-08-2026** and directed to download Tender documents from POF website (www.pof.gov.pk).

5. Earnest money @ 2% of contract amount needs to be deposited in shape of Call Deposit Receipt (CDR) in favour of MD POF SANJWAL CANTT. No tender will be deemed completed and valid unless it is accompanied with Earnest money. Earnest money will be returned to the un-successful tenderers.

6. A/GM Civil POF Sanjwal may reject all bids or proposals any time prior to the acceptance of bids or proposals.
7. Contractors already working with POFs need only furnish particulars of works in hand in POFs and outside POFs with the addresses of clients.
8. Sealed Tenders may be dropped in the Bid Centre Room # 1 Adjacent to Rabta Hall POF Wah Cantt before 1030 Hrs on 13-08-2026 and opening will be held on 13-08-2026 at 1100 Hrs. In case of Public holiday / emergency situation, tender will be received on next working day upto 1030 Hrs and will be opened at 1100 Hrs on the same day.
