## SECTION - I

### INSTRUCTIONS TO THE BIDDERS

#### 1. INTRODUCTION

National Telecommunication Corporation was established in 1996 under Telecommunication Re-Organization Act. NTC has a definite mandate to provide basic telecommunication services to its designated customers, which include Federal and Provincial Governments, their departments, autonomous organizations and defense services throughout the country. Now NTC desires to receive bids for DEPLOYMENT OF GPON NETWORK AT NTC KOHAT

#### 2. ELIGIBILITY CRITERIA OF BIDDERS

Invitation of proposals is open to all firms/contractors who meet following criteria:

- 2.1 Registration with Tax Authorities. The valid Registration be attached with the bid.
- 2.2 Never been black listed. Declaration on stamp papers duly attested be attached with bid.
- 2.3 Having no litigation previously with any government organization. Declaration on stamp papers duly attested be attached with bid.
- 2.4 Registration with PEC in category EE-07 OR EE-08. The valid Registration be attached with the bid
- 2.5 Well reputed firms/contractors having relevant experience.

#### 3. COST OF BIDDING

The bidder shall bear all costs associated with the preparation and submission of its bid and the NTC will in no case be responsible or liable for those costs.

#### 4. AMENDMENT OF BIDDING DOCUMENTS

- 4.1 Any amendment issued shall be part of the tender documents and NTC may at its discretion extend the deadline for submission of bids.
- 4.2 Any such amendment(s) will be ensured by NTC to be provided to all bidders who have already purchased documents within the deadline.

#### 5. BIDDING DOCUMENTS

- 5.1 Bidding documents are comprised of following documents.
  - a. Instruction to bidders.
  - b. General/Special condition of Contract.
  - c. Specifications.
  - d. BoQ
  - e. Contract Form
  - f. Format for Bid security, Bank Guarantee, Performance bonds

#### 6. BID/TENDER SECURITY

- 6.1 The bidder shall deposit a tender security/ earnest money amounting Rs 50,000/-, in the form of Bank Draft / CDR or Pay Order, issued by a scheduled bank of Pakistan, in favor of Director NTC Peshawar, valid for a period of 120 days beyond the bid validity date. The bid security should be furnished separately not in bid.
- 6.2 Any bid not accompanied by an acceptable tender security shall be rejected by the NTC as non-responsive.
- 6.3 The bid/ tender securities of the unsuccessful bidders will be returned upon award of contract to the successful bidder or on expiry of validity of tender security whichever is earlier. The tender securities of bidders, who are not in competition, can be returned earlier at NTC discretion upon receiving a request.
- 6.4 The tender security of the successful bidder will be returned when the bidder has furnished the required Performance Security and signed contract agreement.

#### 7. VALIDITY OF BIDS

- 7.1 Bid shall remain valid for a period of 120 days from the date of tender opening.

#### 8. SUBMISSION OF BID

- 8.1 Bid should be submitted in sealed envelope having necessary information regarding tender notice and bidder(s) name and address and bids should be prepared considering "Single Stage - Single Envelopes" Procedure.
- 8.2 No open, e-mailed or faxed bid will be accepted.
- 8.3 Upon request, acknowledge of receipt will be provided the person making delivery.

## 9 OPENING OF BIDS

**IMPORTANT CONDITIONS OF CONTRACT****1. CONTRACT DOCUMENTS**

The priority of the contract documents shall be as follows.

1. The contract Agreement
2. The letter of Acceptance (LOI)
3. Preamble to condition of contract
4. Condition of contract
5. The Tender
6. The Specifications
7. The schedule of Prices

**2 BOQ**

- 2.1 The contractor shall submit Bill of Quantities to Director NTC Peshawar and the Director NTC Peshawar shall signify his approval /or disapproval as case may be. Approved BoQ shall be signed by Director NTC Peshawar OR his Representative. Any disapproved BoQ shall be modified to meet the requirement of the Director NTC Peshawar and should be resubmitted for the approval of the Director NTC Peshawar.

**3. CONTRACT AGREEMENT**

The Contractor shall, within seven days of initiation of letter of Acceptance , enter into and execute a contract agreement, which will be prepared at the cost of the Contractor in the form prescribed with such modifications and with attachments as may be necessary and as required by the Director NTC Peshawar.

**4. PERFORMANCE SECURITY**

- 4.1 The successful bidder shall deposit a performance security (In the name of Director NTC Peshawar) equivalent to **10% of the total tendered value**, valid for a period of **12 months** beyond the date of completion as per contract.
- 4.2 The performance security shall be further extended if the work is delayed or deemed necessary by Director NTC Peshawar.
- 4.3 The Performance Security shall be released after expiry of the Warranty period, subject to issuance of Final Acceptance Certificate (FAC), by the Divisional Engineer Phones D.I.Khan Division.
- 4.4 The successful bidders / firms shall be bound to provide free service, as and when required by NTC, after completion of work for a period of **12 months**.

**5. INSPECTION ON COMPLETION**

- 5.1 When the work is completed, the contractor shall notify its completion to the Director NTC Peshawar.
- 5.2 Director NTC Peshawar shall constitute inspection committee and shall issue a certificate of completion in respect of the works, subject to approval of inspection committee's report.

**6. DISPUTES AND ARBITRATION**

- 6.1 If a dispute of any kind whatsoever arises between NTC and the Contractor in connection with the works shall be brought into the notice of Director NTC Peshawar, maybe who after thorough investigation resolve the matter amicably and his decision ought to be final.

**7. TIME FOR COMPLETION**

- 7.1 The contractor shall complete the work in all respect within **Six weeks** from the date of issuance of work order by NTC.

**8. PROVISIONAL ACCEPTANCE CERTIFICATE (PAC)**

After successful completion of work the contractor may notify to the NTC concerned officer, the NTC concerned officer will arrange inspection at the earliest. The Provisional Acceptance Certificate (PAC) in favor of contractor, subject to satisfactory completion of work as per inspection report, will be issued by Divisional Engineer Phones D.I.Khan Division.
