TERMS AND CONDITIONS

1. ELIGIBILITY REQUIREMENTS FOR AUCTION

- Any Pakistani citizen possessing a valid Computerized National Identity Card (CNIC) issued by NADRA, along with valid NTN and Sales Tax Registration (where applicable), may participate in the auction. Government employees and defaulters of any Government Department shall not be eligible to participate. Companies/Firms may participate through their duly authorized representatives.
- Each bidder shall submit a Pay Order/Demand Draft equivalent to 2% of the reserve price of the respective lot in favor of Utility Stores Corporation of Pakistan (Pvt.) Limited as a bid security prior to the auction closing date and time. The bid security of unsuccessful bidders shall be refunded after completion of the auction process, whereas the bid security of the successful bidder shall be retained.
- Each bidder shall submit the prescribed bid form along with an affidavit on Rs.100/- stamp paper, declaring that he/she is neither a Government employee nor a defaulter of any Government Department, Autonomous Body, or Public Sector Organization.
- All the government taxes are inclusive in the reserve price.

3. **AUCTION PROCESS**

- a) E-Auction (Ref # D10157) of Poly Granule/Poly and Shopping Bags located at USC Own Brand Warehouse Plot No.290-A Industrial Area, Sector I-9/3 Islamabad
- b) Bidders are strongly encouraged / welcome to visit the site / location, where Poly Granule/Poly and Shopping Bags are lying to get firsthand information / checking of condition etc. of the item before submission of bids for E-Auction (Ref # D10157).
- c) The open E. Auction will be opened at **11:00 A.M** on 15-07-2026 by the disposal committee and will be awarded to the highest price offered bidder against reserve price through EPADS 2.0 for the lot to be auctioned.
- d) Bidders shall submit their offers on a lot-wise basis for the complete quantity of Poly Granules Raw Material and Poly/Shopping Bags (all varieties) included in each lot. The whole lot shall be awarded to the bidder offering the highest responsive bid. Partial bids against individual items within a lot shall not be entertained and shall be treated as non-responsive.
- e) The successful bidder shall be responsible for lifting the awarded material from the designated locations within thirty (30) days from the date of issuance of the award letter and completion of 100% payment, as applicable. All loading, transportation, handling, and related expenses shall be borne by the successful bidder.
- f) The offered/quoted price should be inclusive of all taxes, duties, levies, charges etc including sales tax/FED.
- g) Deposit 100% of quoted amount as per the actual quantities before lifting of the items from the designated stations.
- h) Auction Disposal Committee reserves the right to accept or reject any bid or postpone the E-Auction proceeding without announcing any reason.
- i) Result of the auction proceeding will be placed before the Competent Authority for formal approval.

1. Party B has been declared the successful bidder for auction of Poly Granule's Raw & Poly/Shopping Bags under approved auction process vide Letter No. _____ dated _____, and Party A has agreed to allow lifting of the said stocks strictly in terms of this agreement.
2. M/S _____ (Party B) will lift the stock of Poly Granule's Raw & Poly/Shopping Bags with full advance payment in shape of DD / Pay order in name of Utility Stores Corporation (Party-A) at zonal level.
3. The stocks shall be lifted within reasonable time prescribed by Party A. All expenses including transportation, loading, unloading, labour, taxes and incidental charges shall be borne solely by Party B. The stocks are sold on "as is where is basis" without any warranty or representation, and no claim regarding quality, quantity, shortage or damage shall be entertained after delivery.
4. In case of failure of payment, delay in lifting, or breach of any term of this Agreement, Party A shall have the absolute right to terminate this Agreement wholly or partially without notice, forfeit earnest money or security, cancel allotment, re-auction or risk purchase the stocks at the risk and cost of Party B, and recover any differential amount, loss or damages from Party B.
5. If any lifted material is found to be expired, unusable, unsafe or harmful for human consumption or use, Party B shall not sell distribute or circulate such material to any person or entity. In this event no financial liability will accrue towards Party A, and any such loss will not be adjusted from the auction amount which is full and final. In case Party B violate this clause, Party A shall not be responsible for any consequences, claim or damages.
6. For any violation or breach of any clause of this Agreement by Party B, any financial loss suffered by Party A shall be fully compensated by Party B without prejudice to Party A's right to take legal action under the relevant laws of Pakistan.
7. Any amendment to this Agreement shall only be valid if made through a written addendum duly signed by both Parties.
8. The price of the Auction / Auction Bid is inclusive of Taxes hence no liability of taxes shall accrue towards Party B.
9. In case of any dispute arising out of this Agreement, the Managing Director, USC shall act as sole arbitrator and his decision shall be final and binding upon both Parties.
