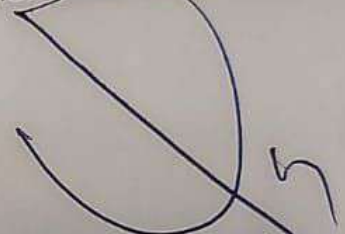
- a. Name of the firm along with (Profile) postal address, phone & Fax #.

- c. Valid Professional tax certificate.
- d. NTN # and evidence of as active tax prayers on ATL of FBR for income tax and sale tax.
- e. No. of Project in hand along with other department and Station Engineer.
- f. Similar nature of works performed in past five years.
- g. Financial status and resources.

3. The application will be scrutinized and the tender documents will only be issued to the scrutinized firms. Tenders must be dropped / delivered in Black Box placed at bid Centre (Rabta Hall) near Gate No. 01 on **22-09-2026** up to 1030hrs. Tenders will be opened on the same date at 1100hrs. in case of public holiday, tenders will be received on next working day upto 1030hrs opened at 1100 hrs on same date.
