These must be registered with the Income Tax and Sales Tax Department, listed on Active Taxpayers List (ATL) of the Federal Board of Revenue (FBR) and duly licensed by the Pakistan Engineering Council in the appropriate category for the following procurement on Delivered Duty Paid (D.D.P.) basis.

3. The electronic bids must be submitted by using EPADS on or before **11.00 Hrs.** on dated **14.09.2026** as per rule-13. Manual bids, shall not be accepted. Electronic Bids will be opened on the same day / date at **11.30 Hrs.** in the o/o Resident Engineer Hydel Power Station Rasul (Mandi Bahauddin)

TERMS & CONDITIONS

- A) Application on original letter pad must contain complete address, contact number (PTCL/Cell).
- B) Bid Security shall be submitted only in the shape of CDR in favor of Resident Engineer Hydel Power Station Rasul. The name of the firm must be mentioned on the CDR. The CDR shall be uploaded with Electronic Bids and original CDR must be submitted to the Resident Engineer Hydel Power Station Rasul (Mandi Bahauddin) on or before E-Bid date & time of closing as mentioned above, otherwise bid security will not be accepted.
- C) Single Stage One Envelope procedure shall be followed for open competitive bidding process.
- D) The Bidders should upload signed and stamped form of Bid/BOQ/Contract Data, otherwise the same will be rejected.
- E) The quoted rates must be inclusive of all applicable government taxes and no rates should be quoted which are exclusive of any tax.
- F) Presentation of false/wrong documents will be strictly discouraged and their Bid Security shall be forfeited besides black listing.
- G) The Bidder shall upload their certificates and details of Active Tax Payer.
- H) WAPDA reserves the rights to accept/reject the bids under the provision of PPRA Rule.

- J) The bidder must have successfully completed similar nature works/contracts during the last five (05) years in any Government, Semi-Government, Autonomous Body, WAPDA, DISCOs, GENCOs, or reputable private organizations.
