The bids will be opened on the same date at 11:30 a.m. in the presence of the bidders or their authorized representatives who are present.
4. Export Processing Zones Authority, Karachi reserves right to accept or reject any or all bids prior to acceptance as per PPRA's Rules 2004.

TERMS & CONDITIOINS

1. Firm should have its appropriate office in Karachi, phone number and it must be operating in the market itself.
2. The firms participating in the tender must have their Income Tax Number, General Sales Tax Number, Sales Tax Registration Number (STRN) and Vendor number which are linked with FBR. Firms must submit a copy of certificate of Registration with Sale Tax Department.
3. Bid security not exceeding five percent (5%) of the bid price, as bid security in the form of pay order/bank draft, in favour of Export Processing Zones Authority Karachi, must reach the office of Secretary, EPZA, Ministry of Industries & Production Karachi, latest by 10-02-2026. The bid will be opened on the same date at 11:30 a.m. in the presence of the bidders or their authorized representatives who are present.
4. The Bid security of successful bidders shall be retained and will be returned after the completion of work. It will be returned to the un-successful bidders after finalization of the tenders.
5. The successful firms will be bound to supply the uniform in this office of Export Processing Zones Authority Head office Karachi, on the rates quoted in the tender.
6. In case of uniform provided by the firms are found sub-standard, the competent authority of this office reserves right to cancel the award for supply of tender items wholly or partially without assigning any notice.
7. Bid security will be forfeited if the firms who fail to provide uniform(s) qualitatively good and the defaulter firm(s) will be declared blacklisted.
8. For supply of uniform, the successful firm(s) will be required to present their samples after the opening of tenders. The samples of the successful firms will be kept in safe custody of the KEPZ.
9. Any bidder feeling aggrieved by any act of the procuring agency after the submission of his bid may lodge a written complaint concerning his grievances not later than three (03) days after the announcement of the bid.
10. The firm should have minimum five (05) years' experience in supply of relevant items. The experience will be determined from date of issue of NTN/ GST Certificate.
11. Delivery must be made at EPZA Head office Karachi, within THIRTY (30) days after issuance of the work / purchase order.

General Terms & Conditions

- A) The interested parties should quote their rates with GST only for the items mentioned in the enclosed list.
- b) Any emergent demand or order placed by Admin Division of this office on telephone/ fax, as the case may be, must be met by the supplier(s) within the stipulated time period.
- C) The quality of the articles must be in accordance with the specifications given in the attached list, failing which the supply shall be rejected at the risk and cost of the supplier for which Export Processing Zones Authority reserves the legal rights to claim the cost on account of delay/ suffering of official work.
- D) Uniform shall be strictly in accordance with approved sample, quality, quantity, colour, design, individual fitting and stitching etc.
- E) Strong thread is required to be used in stitching of uniform. In case thread comes off within one year, re-stitching will have to be done without any additional charges. If re-stitching of any uniform is arranged from another tailor of our own choice, the cost of re-stitching will have to be paid by the supplier.
- F) In case of shrinking take place or colour faded within one year, the uniform will have to be replaced with new one without any additional charges.
- G) The ten (10) % retention money will be deducted from the final bill and this will be return after one year.
- H) The supplier(s) shall be responsible for delivery of the articles in the office without any additional charges.
- I) There shall be no compromise on quality/quantity. Export Processing Zones Authority reserves the right to penalize the supplier(s) in case of supply of inferior quality or short packing of the articles.
- J) In case of failure in satisfactory supply, the security shall be liable to be forfeited.
