2. Bid documents, including the method of procurement detailed terms and conditions, are available on the PPRA E-PAD System (<https://eprocure.gov.pk>).

3. To participate in the tender process, bidders must submit following documents with technical bid:
- Valid registration with federal Board of Revenue (FBR) and listing on the Active Taxpayer List (ATL)
 - A valid Professional Tax Certificate
 - Updated Pakistan Engineering Council (PEC) Registration in Category C-5 or above for the current year.
 - Affidavits confirming
 - Ownership of the firm.
 - No blacklisting
 - Details of pending litigation, if any
 - Audited Financial Statements for the last 3 years
 - Documentary evidence for Average annual turnover of the last Three (03) years must be Rs. Twenty (20) Million or above
 - Original Bid Security in an acceptable form in the prescribed amount
 - Work completion certificate of at least two civil works projects, each worth more than Rs. Twenty (20) Million.

4. Financial bid must be submitted separately and must comprise priced bill of quantities only. Financial bid of only technically qualified bidders, who fulfil the above criteria and furnish the required documentary evidence, shall be opened.

5. Bid security in the form of Pay Order / Bank Draft from any schedule bank should be drawn in favour of PAKISTAN AIRPORTS AUTHORITY AIAP, Lahore. The original bid security must be submitted in person to the office of the undersigned on the due date and time.

6. The Bidders must submit their bids along with requisite documents electronically through the PPRA E-PADS Web Portal (<https://eprocure.gov.pk>) before the submission deadline. The bidders are also required to submit the bids in hard form alongwith requisite documents mentioned in the tender notice on due date & time in the office of the undersigned in sealed envelope.

7. PAA reserves all rights to accept or reject any or all the tenders as per PPRA rules.

8. Any overwriting/crossing, etc. appearing in the offer may be properly signed by the person signing the bid. All pages of the bid must be properly signed. Offer with any use of Blanco shall not be accepted in any circumstances.
