Terms & Conditions:

- a) Sealed bids (on the prescribed bid form) addressed to the General Manager (Maintenance) NHA (Punjab-South) Multan will be received **at 1130 hours on 10-03-2026** and will be opened **at 1200 hours** on the same day, in the presence of all bidders or their authorized representatives who may choose to attend.
- b) Bids should be free from cutting/overwriting and amount be written both in figures as well as in words which must be clear and legible.
- c) The bidder shall submit the separate Bid for each lot accompanied by separate bid security for each lot in the shape of CDR/DD/PO of **Rs. 75,000/- in the name of General Manager (Punjab-South) NHA, Retention Money Account**. Bid security of 1st, 2nd and 3rd highest bidders shall be retained till finalization of auction process. Failure to furnish the bid security shall lead to disqualification/rejection of respective bid.
- d) The highest bidder of each lot shall submit **25%** of his highest offered bid price at the spot in the form of CDR/DD/PO in the name of **General Manager (Punjab-South) NHA, Retention Money Account**, failing which the bid shall be rejected and bid security of the respective bidder shall be forfeited. All Government Tax (es) and charges (whatsoever admissible) will be applicable/levied as per prevailing Government Rules.
- e) The successful bidder shall be required to deposit the balance amount of highest bid within **06x working days** from the date of acceptance of the bid by the competent authority. If successful bidder fails to deposit remaining balance amount within the prescribed time, the bid security of Rs. 75,000/- for each lot and 25% of highest bid amount submitted in NHA shall be forfeited and NHA may re-auction the dead stock at its will. No claim whatsoever of such bidder will be accepted by NHA.

- f) The successful/highest bidder will be accorded written permission for removal/shifting of auctioned dead stock within specified time after depositing full payment including all applicable taxes. If the successful bidder fails to remove/shift the auctioned dead stock from the respective locations within specified time, ground rent per day as per NHA rules/regulations shall be recovered from the successful bidder before the auctioned items are removed.
- g) Queries (if any) can be cleared from the office of Deputy Director (Admin) NHA (Punjab-South) Multan till 09-03-2026. No objection after bid opening shall be entertained and decision of Auction Committee in case of any dispute shall be final.
- h) NHA reserves the right to reject all bids or proposals in accordance with the PPRA Rule No. 33(1).
