2. **Terms and Conditions:-**

a.	Earnest Money 2% (with max limit of 1 Million) of the value of Total Contract Value refundable by the Registered Firms is required to be deposited by the bidder in the shape of bank draft at the time of tendering in favour of "Headquarter Karachi Logistics Area". Cheque or cash is not acceptable.
b.	Earnest Money will be confiscated in case of withdrawal of contractor's offer after opening of IT (Invitation to Tender) in Log Area / receipt of CST in S&T Dte.
c.	Rates are required to be quoted with and without transportation charges (upto 2000 KMs all over the country).
d.	The rates tendered include all type of Provincial / Central Government taxes.
e.	Sealed quotations will be dropped in Tender Box at Headquarters Karachi Logistics Area latest by 1100 hours on 09 March 2026 and will be opened at 1100 hrs on 10 March 2026 .
f.	The rates quoted by the firms should be valid upto 10 July 2026 under one year warranty period for replacement of the stock. Quantities can be increased or decreased upto 15% during procurement period.
g.	Quotation will be accepted on the basis of rate of each individual item / commodity and not on the basis of overall value of the tender.
h.	Specifications / Acceptance standard can be obtained from this office during working hours from Monday-Friday (0900-1500 hours)
i.	Deposit 1 Liter / No / Kg sample of above mentioned items at the time of tendering.
j.	Quotations received after due time / date will be rejected on the spot.
k.	Quotations / Offers can be rejected by Board of Officers in case of following:-
(1)	Not depositing required Earnest Money while offering quotations.
(2)	Firms blacklisted / banned by any organization of Govt. of Pakistan / Pakistan Army.
(3)	Not willing to offer the stock within 15 days on receipt of acceptance notice / LPOs , or as per DP (Delivery Period), whichever is later.
(4)	Firm's previous performance for procurement of H&C items being un-satisfactory .
(5)	Any error / over writing or doubt in the rates offered which cannot be verified or acceptable.
(6)	IT (Invitation to Tender) not submitted in accordance with govt regulations.
l.	Rates of items will be announced to the audience upon opening of tender.
m.	Offered stock will be accepted subject to laboratory testing.
n.	In case of non-delivery of consignment as per Delivery Period (DP) given in this contract, Late Delivery (LD) charges may be imposed upon the firm as per following:-
(1)	1 x Day after expiry of DP - 5% of the Total Tender Value
(2)	2 x Days after expiry of DP - 5% addl (Total 10%) of Total Tender Value
(3)	3 x Days after expiry of DP - 5% addl (Total 15%) of Total Tender Value
(4)	5 x Days after expiry of DP - 5% addl (Total 20%) of Total Tender Value

	(5) 10 x Days after expiry of DP -	Tender shall be cancelled & “ Earnest Money ” shall be confiscated.
o.	In case of failure of the firm to complete “ CONTRACTUAL OBLIGATIONS ”, the “ EARNEST MONEY ” may be confiscated (partial on whole). Moreover, Headquarters Karachi Logistics Area shall have right to process case for “ BLACK LISTING ” or cancellation of “ Registration of Firm ” or both.	
p.	In case of showing inability by contractor to provide the stores within stipulated period / required quantity and withdrawal of offer or any excuse after issuance of LPO (Local Purchase Order), required store will be purchased at Risk and Expenses and difference of amount / cost will be recovered from the defaulter firm on the direction of Supply & Transport Directorate.	
q.	ID Mark number of LP order will be endorsed on each pack.	
r.	WARRANTY. The consignment offered by the firm shall have “ WARRANTY ” of 1 Year from the date of acceptance of consignment. In case of any complaint / deterioration, the subject item / consignment shall be replaced by the firm at own expense.	
s.	Security deposit (Earnest Money Draft) will be refunded to firm after expiry of “Warranty Period” of secured items, and NOC from Consignee Depot.	
t.	Consignment will be delivered by the contractor at Station Supply Depot Army Service Corps Malir Cantt / Station Supply Depot Army Service Corps Karachi at contractor’s own expense within Delivery Period (DP). In case “WITH TRANSPORTATION” the firm shall provide consignment anywhere in Pakistan (upto 2000 Km) without any additional charges.	
u.	Consignment should be in accordance with Army Service Corps specification (Anx-A). Stock will be accepted after testing and declared fit by the authorized Laboratory i.e IAS&C Laboratory Karachi.
