The prospective bidders are also required to submit an undertaking on stamp paper duly attested by notary public worth not less than Rs. 50/- that the firm / contractor are neither involved in any litigation nor black listed by any government, Semi government of autonomous body in Pakistan and also undertakes that if any information or document provided by firm for issuance of tender document is found incorrect or fictitious that firm is liable for disqualification and legal action under the law.
