PART-A: INSTRUCTIONS TO BIDDERS/PARTICIPANTS

A. INSTRUCTIONS TO BIDDERS/PARTICIPANTS	
Scope of Bid	Multan Electric Power Company (MEPCO) Ltd. wishes to receive E-Bids as per disposal notice and Bidding documents. Bidders can submit bids for one or more Items. Successful bidder will be declared for each Item separately on the basis of highest offer rate.
Language of Bid	The bid prepared by the Bidder, as well as all correspondence and documents relating to the bid exchanged by the Bidder and the MEPCO shall be in English or Urdu (as the case may be).
Clarification of Bidding Document, Meeting and Site Visit	A prospective Bidder requiring any clarification of the Bidding Documents may approach the Office of Director (Procurement) Distribution in writing at the given address or EPADS within specified time. MEPCO will respond in writing to any request for clarification of the Bidding Documents on EPADS that it receives no later than seven (07) days before the deadline of submission of bids. Copies of the MEPCO's response (including an explanation of the query but not identifying its source) will be sent to all prospective Bidders that received the Bidding Documents from the MEPCO. Interested bidders can visit/inspect the scrap material on working days between 09:00 AM to 04:00 PM
Amendment of Bidding Documents:	At any time before the deadline for submission of bids, MEPCO, for any reason, either at its initiative or in response to a clarification requested by a prospective Bidder, amend the Bidding Documents. Such amendments shall take precedence over the existing document. The addendum will be binding on Bidders. It will be assumed that the amendments contained in such Addendum will have been taken into account by the Bidder in its bid.
Access to Disposal Scrap	The interested bidders are strongly encouraged to visit the stores within time specified to get first-hand information regarding the condition, make etc. of the items and their quantum before submitting the quotations. Interested Bidders Shall follow the MEPCO's security protocols for visiting the stores.
Condition and Specification	Item of disposal will be sold on Item wise " As is Where is basis ".
Location of Material	As per stores mentioned in Tender Advertisement / Bidding Documents.
Qualification of the Bidder	To qualify for the award of the Contract, bidders must meet the mandatory Evaluation criteria, as specified in the Bidding Document.
Deadline for Submission of E-Bid	E-Bids should be submitted on EPADS before deadline of Bid submission. The tender shall be opened through EPADS in the presence of the bidders or their authorized representatives who may like to be present during the session.
Manual Bid Submission	Manual Bid is not accepted and if received (either through an authorized representative or courier/postal service) will be returned unopened to the Bidder.
One Bid per Bidder	Each Bidder shall submit only one Bid individually.
Cost of Bidding	The Bidder shall bear all costs associated with the preparation and submission of its bid, and the MEPCO in no case be held responsible or liable for those costs.
Method Of Bidding	Single Stage One Envelop Bidding Procedure as per PPRA Rules.
Bid Validity	Validity of bid from the opening date: 120 Days
Bid Security	Bid Security as tabulated in Tender advertisement/ Bidding Documents in the form of CDR /Pay order/demand draft shall have to be submitted along with the Bid by the bidders for participation. Part C: General Conditions of Contract

1	Applicable Law	The Contract shall be governed by the laws of the Islamic Republic of Pakistan.
2	Authorized Representatives	Any action required or permitted to be taken, and any document required or permitted to be executed, under this Contract by the MEPCO or the Contractor may be taken or executed by the officials specified in the SCC.
3	Taxes, Duties and other applicable laws.	The Contractor shall ensure compliance with local laws and applicable regulations. Any additional tax, levies, duties, or modification in the existing rates of tax and other applicable laws imposed during the pendency of this contract shall be paid by bidder.
4	Currency of Bid	The Unit rate and the prices shall be quoted by Bidder entirely in Pak Rupees
5	Effectiveness of Contract	This Contract shall come into effect on the date the Contract is signed by both parties or such date as may be stated in the Special Conditions of Contract .
6	Force Majeure	<u>Definition</u> For this Contract, "Force Majeure" means an unforeseeable event that is beyond the reasonable control of a Party, and which makes a Party's performance of its obligations under the Contract impossible as to be considered impossible under the circumstances. The Party affected by Force Majeure shall on the occurrence of such event leading to Force Majeure, immediately notify the other Party in writing and take all reasonable steps to overcome the Force Majeure.
		<u>No Breach of Contract</u> The failure of a Party to fulfill any of its obligations under the contract shall not be considered to be a breach of or default under this Contract, insofar as such inability arises from an event of Force Majeure, provided that the party affected by such an event;

5.	Lifting Period of Scrap Material	The contractor shall lift the allotted scarp material as per contract within 21 Days from the date of issuance of Release Order unless & otherwise extended by MEPCO, under supervision of MEPCO nominated committee.
6.	Sub-Contracting	Sub-Contracting is NOT allowed under any circumstances.
7.	Penalty	It would be binding for the contractor to lift the allotted quantity of scrap material within the specified time. Failure to do so shall result in a penalty in shape of rental charges @ 0.1% per day upto maximum 10% of the total value of the stores will be charged until such time all stores be removed from the site.
8.	Payment	Contractor shall have to deposit 100% payment (inclusive of All applicable taxes) (after adjustment of his bid security) within (21) working days from issuance of Notification of Award/LOA, upon the realization of payment in MEPCO account Release Order shall be issued as per the quantities/weights allotted in the Release Order. The weights/counting shall be carried out in the presence of MEPCO's representative(s) at spot before lifting the items. A. Contractor will not be allowed to lift any extra quantity beyond his Release Order B. If actual quantities (Weight/Number) are found less at site with respect to defined as per Release Order the balance payment will be returned to the contractor after successful completion of his work. Further, the Contractor is solely responsible for payment of all applicable taxes/levies etc. (if any) which will be adjusted from his offered rate, to respective authorities without any cost and consequences to be charged to the MEPCO. In case

		of any change in rate of any tax by Government of Pakistan (GOP) after opening of tender / Bid, successful bidder shall pay the revised rate notified by the GOP.
9.	Price Adjustment	No Price Adjustment shall be made for any variation in the market prices, taxes/ duties or change in wages or the Law.
10.	Lifting Cost and Cost of Transportation	The scrap material is to be lifted by the bidder at his own cost, transportation and labor, failing which a penalty of 1% of the bid amount per day till such time the entire quantity is removed from the site will be imposed. While Lifting of Material the contractor shall comply with the Safety SOPs and provide necessary PPE to the labour involved in lifting the scrap material. Any mishap occurred to the personal shall be responsibility of the contractor.
11.	Lifting of Scrap	The contractor would be responsible to arrange vehicle(s) and suitable number of workers for lifting of Scrap at his own cost. The Contractor will provide in advance the details of any vehicle(s) that is required to enter the premises of the MEPCO Stores for lifting of Scrap material along with the details of the driver(s) of the vehicle and labor(s) involved in lifting of material. The Contractor shall be responsible for engaging adequate number of manpower for providing quality services in including their hygienic conditions/manners.
12.	Time Schedule for Lifting	The contractor shall provide services during working hours on working days or on any other day and timing including gazette holidays (if required by the MEPCO)
13.	Requirement of Gate Pass	Scrap will be taken out from the MEPCO's premises upon issuance of "Gate Pass" by the MEPCO authorities.
14.	Use of MEPCO's Property	The Contractor shall not make any kind of excavation or construction including alteration or modification in the premises, including electrical appliances, sanitary fittings and other fitting/equipment, without the permission of MEPCO in writing and further he shall have no right to use MEPCO's property for his employee's personal purpose and residence.
15.	Notification of Award/ LOA	The notification of award will be issued to bidder complied with evaluation criteria and quoted highest rates. The successful bidder is obliged to accept "letter of acceptance"/Notification of Award (NOA) within (21) working Days of issuance, failing which, their bid security may be forfeited and the MEPCO reserve the right to award the work to the 2 nd Highest Bidder.
16.	Engagement in Other Business Activities	The resource person will not be allowed to engage in any other business activity related to the MEPCO. A strict punitive action will be taken against him if he ever found indulged in such acts and the decision of Chief Supply Chain Management Officer MEPCO will be final on this matter.
17.	Failure to Accept NOA/LOA or Deposit Payment	In case the successful bidder refuses to accept NOA/LOA or fails to Deposit Payment withing stipulated period or fails to perform his obligations within stipulated or extended time of the contract, the Bid Security shall be forfeited and the contractor shall be blacklisted/debarred for participation in future tenders of the MEPCO as per MEPCO Blacklisting/Debarment Policy available at MEPCO Website.
