If your bid is not accompanied by the requisite **Bid Securing Declaration** (in original) , will not be read out at the time of tender opening and will be considered as **non-responsive**.
5. All tenders shall be publicly opened at **1130 hours** on the same day in our office at the above mentioned address. Only One Representative of each bidder possessing a 'Letter of Authority' to do so, may attend the bid opening, if desired.
