Tenders will only be issued to the scrutinized contractors. The tenders must be received in the office of the Accepting Officer by **1130 hours** on **11<sup>th</sup> May 2026** and tender will be opened on **11<sup>th</sup> May 2026** at **1200 hours**.

**NOTE:** Contractor shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ Rwp) is outstanding against them.

3. Firms/Contractors not borne on approved list of MES will furnish a certificate along with their applications, giving details of works executed during last two years and those in hand on the proforma appended below: -


5. Contractors borne on approved list of MES in Category "A", "B", "C" & "D" and also having experience of this type should only apply.
