TENDER DOCUMENT

The requirement for installation of fiber optic based internet in the FTO Secretariat HQ, Islamabad and Regional Offices is as under:-

The terms and conditions are as follows:-

- Interested Internet Service Providers (ISPs) may visit the sites for finalization of their proposals on any working day between 09:00 am to 2:00 pm.
- Only registered supplier who are on active taxpayers list (ATL) of FBR are eligible to Supply goods / services to Government departments.
- The firm will have to provide free of cost maintenance, repair and replacement of parts along with complete installation. The successful bidders would be responsible for installation of products/services at FTO Secretariat HQ Islamabad as well as in Regional Offices. The detailed information of sight/premises may be collected from Assistant Director, FTO, Sectt, HQ Islamabad.
- **The bidding procedure shall be single stage two envelopes procedure.** The bid shall comprise a single package containing two separate envelopes. Each envelop shall contain separately the financial proposal and the technical proposal. Financial proposal of only those bidders will be opened whose technical proposals are accepted by the Purchase Committee. The financial proposal of those bidders which found technically non-responsive shall be returned unopened to the respective bidder.

- The tender document may be downloaded from e-Pak Acquisition & Disposal System (EPADS) Version 2.0 which is available online at official website of Public Procurement Regulatory Authority (PPRA).
- The firm shall upload the tender through EPADS Version 2.0 latest by **18 May – 2026 09:30 hours** after which no tender will be entertained.
- Purchase Committee of FTO Secretariat shall open the technical proposal the same day i.e. **18-05-2026 at 11:00 hours** in the FTO Secretariat HQ Islamabad, in presence of the bidders/representatives of their firms and the committee will evaluate the technical proposal in accordance with the specified evaluation criteria. The financial proposal shall be opened at a time communicated to the bidder in advance.
- All the bidders will have to submit proof of GST registration, NTN number and a certificate to the effect that the firm/ISP was never blacklisted by any Government department.
- Earnest money equal to 2% of the total value of quoted tender cost in the form of call deposit in the name of DDO FTO Secretariat shall be attached with the financial proposal.
- The office reserves the right to accept or reject any or all offers in the light of PPRA, Rules.
- Incomplete and late submission of tenders shall not be considered.
