Request for issuance of IT will be entertained 07 days before opening date of tender.
 - A treasury Challan of Rs. 2,000/- debatable to Main Head XLVII Main Head XII Sub Head A is required to be submitted by the un-registered / un-indexed firms along with the request.

 - Firm past performance based on their previous defaulted contracts, late deliveries / late submission of BGs will be considered as essential bench mark in acceptance or rejection of quotations.
