2. Tender will be opened on 17-06-2026 at **10:30am** in conference room of **PAEC General Hospital Sector H-11/4, (opposite Police Lines) Islamabad** in the presence of bidders who may like to attend. In case of falling holiday on the opening date, the tenders will be opened on the next working day at the same time.
3. Said equipments / machinery can be physically inspected during office hours 8:30 am to 2:00 pm at below mentioned premises till auction day.
4. Copy of CNIC, tax profiles / registration letters, ATL Status and contact details may be submitted along with proposal.
5. The bidder must deposit 2% (refundable/adjustable) of the total offered amount in the shape of demand draft/pay order in favour of Head LAO, PAEC General Hospital, H-11/4, Islamabad as earnest money along with proposal.
6. Bids without or less earnest money will not be accepted.
7. The successful bidder(s) shall have to deposit the balance amount within 05 days w.e.f auction approval of Competent Authority, failing which the earnest money shall be forfeited. Earnest money would be refunded to unsuccessful bidder(s) subject to auction approval of Competent Authority.

8. The successful bidder(s) shall have to pay all government taxes as applicable in addition to bid amount.
