1. These terms and conditions are applicable for Replacement of Sui Gas Lines installed at National Institute of Health, Islamabad on F.O.R. Basis.
2. These terms and conditions are in harmony with PPRA rules.
3. This process follows Single stage Single envelope procedure as per PPRA.
4. No tender will be considered after due date and time. Unsealed tenders will not be accepted.

TERMS & CONDITIONS:

1. **Tender Name:** Replacement of Sui Gas Lines Installed at National Institute of Health, Islamabad

Time of Completion: 60 days

Bid Security validity period: 210 days

Tender Type: Single Stage Single envelope bidding procedure as per PPRA

2. Tender documents on “F.O.R NIH, Islamabad basis” with complete specifications can be obtained from the Finance Division of this Institute after depositing of Rs.1000/- (Non-refundable) as tender fee. Original receipt of tender fee must be enclosed with the tender documents.
3. All the tenderers are required to enclose a Bank draft/Call deposit of Rs. 100,000/- (Rupees one lac only) **TO BE ATTACHED WITH BID** as earnest money of the quoted amount in the name of Executive Director, NIH, Islamabad. No other negotiable document except Bank draft/ Call deposit will be accepted. Any Previous security will not be considered for this tender. The tender of any firm/bidder who does not enclose the fix earnest money/short earnest money in the shape of bank draft/call deposit along with the tender documents, will not be considered. Earnest money will be returned to unsuccessful and successful bidders after award of contract.
4. 10 % performance security is to be submitted by a successful bidder in the name of Executive Director, NIH, Islamabad. No other negotiable document except Bank draft/ Call deposit will be accepted. Any Previous security will not be considered for this tender. **Validity of performance security should be till 30 days after completion date of project. Performance security will be returned after completion of project satisfactorily.**
5. Retention money of 5% will be deducted from final bill submitted by contractor which will be returned after completion of DLP (Defect liability period). DLP is 06 months for this work.

Technical Evaluation Criteria as per clause 6:

6. Bids of only those firms will be considered responsive who have following documents attached with Bid. *(In case of non-submission of any document, the bid shall be instantly rejected):*
 - a. CNIC of Owner of the Firm
 - b. Active NTN (issued by FBR) status on the date of opening of bid.

- c. Active STRN (issued by FBR) status on the date of opening of bid.
- d. Bidders should have PEC valid license at the time of opening of bid, of Category C6 or above.
- e. Approved/valid SNGPL contractor (proof /letter to be attached for this).
- f. Copies of PEC registration, SNGPL registration/enlistment and Fusion welder certifications shall be submitted with the bid or proof of SNGPL approved staff related to welding.
- g. At least **03 Completed projects** of similar nature of at least 1 million Rupees within **past 5 years**. (Work order and Completion Certificate to be Attached)
- h. Affidavit that firm is not blacklisted.

Obligation of Contractor as per Clause 7:

- 7. C6 or above PEC approved contractor will be required to follow following conditions in this contract /work:
 - a. Contractor will be responsible for pre-visit of site before submission of bid and evaluate the price as per site and BOQs required.
 - b. BOQs are to be followed completely in all respects.
 - c. Payment will only be done when work is achieved as per BOQs. Any minor/major damage occurs during the work will be responsibility of the contractor.
- 8. The Chief Executive Officer, NIH is not bound to issue work order against all work items of BOQs mentioned in the tender form. He may issue work order either for less or more quantity as per requirement of the concerned departments.
- 9. The contractor shall have to obey all the instructions issued to him from time to time by the Chief Executive Officer, NIH, Islamabad, or his authorized officer in connection with work required.
- 10. The Chief Executive Officer, NIH is the final authority to decide any dispute and problem if any during contract period and thereafter, the decision of the Chief Executive Officer shall be final and binding on the supplier/contractor.
- 11. Quoted rates must be exclusive GST. A copy of sales tax registration certificate must be enclosed. In case of any escalation in rates of the item(s) during the period of contract, NIH, Islamabad will not be liable on this account and the contractor is bound to complete the supply in any case.
- 12. Any query/clarification, if required, can be obtained from Purchase & Procurement Department of this Institute at least 05 days before opening of technical bid. Conditional or incomplete tenders will not be accepted.
- 13. The rates should be quoted for the given specification. The alternate specification given by the Contractor will not be considered. The tender of those bidders whose rates are found un-realistic will not be considered.
- 14. The rates quoted in the tender should be **properly typed or clearly legible written. Erasing, overwriting, and using fluid will amount to disqualification.**

15. All works should be completed within Time of completion Specified in clause 1, and failure to complete the work within mentioned time period without proper justification can result in termination of contract. In this case performance security money of supplier/contractor will be forfeited and firm will be **Black Listed** to take part in the tender competition for supply to NIH in future. This action will be publicized for general awareness of the Government and Semi Government Departments.
16. NIH will be entitled at its discretion, to claim liquidated damages up to 0.05% of bid amount per day in case of delayed works. In case of extension of time, updated performance security with extended date may be submitted.
17. Last date of the receipt of tender is **21.05.2026 at at 11.00** a.m. No tender will be received after due date and time.
18. **Single Stage Single Envelope bidding procedure shall be applied.** The amount of the earnest money i.e. Rs. 100,000/- in the shape of the Bank Draft/CDR is required to be supported inside bid sealed envelope.
19. The bidder will have to declare in advance any conflict of interest in the form of any relationship or relative working in NIH.
20. The sealed envelope should be marked and **“Tender for Replacement of Sui Gas Lines installed at National Institute of Health, Islamabad”** on the left corner of the envelope and put in the relevant tender box placed in the office of the **Director Purchase and Procurement, National Institute of Health, Chak Shahzad, Islamabad**
21. The terms and conditions of the tender, duly accepted/signed by the bidder must also be attached with the quotation.
22. In case failure to complete the works, Work order will be cancelled with forfeiture of 10% performance security money. The case will also be put to PPRA for **BLACK LISTING** to take part in the tender competition for supply of store to NIH in future. This action will publicized for general awareness of other Government and Semi Government Departments/PPRA website.
23. All the bidders are informed that according to Section-3 S.No. 22A (b) contained in Schedule-1 to Stamp Act-1899 regarding procurement of store and material, in case of agreement made or entered in to by a contractor agency or organization set up or controlled by the federal or the Provincial Govt. Stamp Duty @ Rupees twenty five paise for every one hundred rupees or part thereof of the amount by the Finance Division of this Institute.
24. Contract will be made on Stamp Paper (no-judicial) for Rs.100/- only beyond the amount of Rs.10.00 Million or technicality involved.
25. Form of contract is attached as Annex-A.
26. The Competent Authority, Islamabad reserves the right to accept or reject any tender/all tenders without assigning any reason thereof.

WHEREAS the Employer is desirous that certain Works, viz _____ should be executed by the Contractor and has accepted a Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW this Agreement witnesseth as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the terms and Conditions of Contract hereinafter referred to.
2. The following documents after incorporating addenda, if any except those parts relating to Instructions to Bidders, shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (a) The Letter of Acceptance of Bid
 - (b) Terms and Conditions duly signed by Employer and Successful Bidder
3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy defects therein in conformity and in all respects within the provisions of the Contract.
4. The Employer hereby covenants to pay the Contractor, in consideration of the execution and completion of the Works as per provisions of the Contract, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.

 - Final alignment
 - Preparation of new drawings of gas pipelines after installation of said lines.
 - Obtaining all approvals from SNGPL (as or if required)
- Any changes required as per SNGPL standard during execution shall be implemented without extra cost.

7. Safety & Compliance

- Contractor shall comply with:
 - SNGPL safety codes
 - OGRA regulations
 - PEC guidelines
 - Local safety laws
- Contractor shall arrange:
 - Signage
 - Fire extinguishers (during the work if deemed necessary)
 - Gas detectors (if required)
- Any accident, leakage, damage, or safety incident shall be sole responsibility of the contractor.

8. Warranty & Defect Liability

- Contractor shall provide a minimum 12-month defect liability / warranty period from the date of successful commissioning.
- Any leakage, failure, joint defect, or material fault during warranty period shall be rectified at contractor's own cost.
