Which expression shall include their heirs, successors in both cases witnessed that whereas the contractor quoted the rates and the rates approved by the Board vide CBR No. _____ dated _____ 2026 at the rate of M.E.S. Schedule of Rates 2021 bid amount Rs. _____ for Scheduled items and bid amount Rs. _____ for Non-Schedule items for the work _____ on the following terms and conditions at an estimated cost of Rs. _____ Million.

1. That the work _____ will be carried out by the Contractor according to the specifications given in the M.E.S. Schedule of Rates 2021 (amended to date), plans in conformity with the terms and conditions laid down in the tender notice and M.E.S. Schedule of Rates 2021 (amended to date).
2. That the work will be carried out strictly in accordance with the drawings plans and specifications attached with the tender. 6. That the accredited agent of the contractor shall always be present at the site of work to receive the orders issued by the Inspecting Officer. He will also attend the office of the C.E.O. at least once a day during office hours to receive necessary orders/instructions in connection with construction of work. The name of such accredited agent will be notified in writing to the C.E.O.

7. That the Cantonment Board whose decision shall be final and conclusive shall cancel the contract on any of the following cases and the contractor shall be liable to make payment of any loss or damage resulting from any such cancellation:-

10. That the work will be executed in workmanlike manner to the satisfaction in all respects of the C.E.O/ Engineer Incharge. Should the C.E.O / Engineer Incharge at any time during construction feel that any work has been executed with unsound, imperfect or unskilled workmanship or of a quality inferior to the constructed for, or otherwise in accordance with the contract, the contractor shall on demand in writing from the C.E.O / Engineer Incharge specifying the faults, notwithstanding that the same have been inadvertently passed at his own expenditure and in the event of his failing to do so within a period to be specified by the C.E.O / Engineer Incharge, the work shall be carried out by other means at the risk and cost/expenditure of the contractor.
11.
