## **SECTION II: INSTRUCTION TO BIDDERS (ITBs)**

### **A. INTRODUCTION**

<b>1. Scope of Bid</b>	1.1.	The Procuring Agency (PA), as indicated in the <b>Bid Data Sheet (BDS)</b> , invites Bids for the <b><i>Supply, Installation, Integration Maintenance &amp; Technical Support of UPS Systems for SBP DR Site Hyderabad</i></b> as specified in the BDS and <b>Section V - Technical Specifications &amp; Schedule of Requirements</b> . The successful Bidders will be expected to supply and install the information systems within the specified period and timeline(s) as stated in the <b>BDS</b> .
	1.2.	Unless otherwise stated throughout this document definitions and interpretations shall be as prescribed in the General Conditions of the Contract (GCC).
<b>2. Source of Funds</b>	2.1.	Source of funds is referred to in Clause-2 of Invitation for Bids.
<b>3. Eligible Bidders</b>	3.1.	A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the members of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract.
	3.2.	The appointment of Lead Member in the joint venture, consortium, or association shall be confirmed by submission of a valid Power of Attorney to the Procuring Agency.
	3.3.	Verifiable copy of the agreement that forms a joint venture, consortium or association shall be required to be submitted as part of the Bid.
	3.4.	Any bid submitted by the joint venture, consortium or association shall indicate the part of proposed contract to be performed by each party and each party shall be evaluated (or post qualified if required) with respect to its contribution only, and the responsibilities of each party shall not be substantially altered without prior written approval of the Procuring Agency and in line with any instructions issued by the Authority.
	3.5.	The invitation for Bids is open to all prospective supplier, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing by the respective national incorporating

		agency or statutory body established for that particular trade or business.
	3.6.	Foreign Bidders must be locally registered with the appropriate national incorporating body or the statutory body, before participating in the national/international competitive tendering with the exception of such procurements made by the foreign missions of Pakistan. For such purpose the bidder must have to initiate the registration process before the bid submission and the necessary evidence shall be submitted to the procuring agency along with their bid, however, the final award will be subject to the complete registration process.
	3.7.	<p>A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidders may be considered to have a conflict of interest with one or more parties in this Bidding process, if they:</p> <ul style="list-style-type: none"> <li>a) are associated or have been associated in the past, directly or indirectly with a firm or any of its affiliates which have been engaged by the Procuring Agency to provide consulting services for the preparation of the design, specifications and other documents to be used for the procurement of the information systems to be procured under this Invitation for Bids.</li> <li>b) have controlling shareholders in common; or</li> <li>c) receive or have received any direct or indirect subsidy from any of them; or</li> <li>d) have the same legal representative for purposes of this Bid; or</li> <li>e) have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another Bidder, or influence the decisions of the Procuring Agency regarding this Bidding process; or</li> <li>f) Submit more than one Bid in this Bidding process.</li> </ul>
	3.8.	<p>A Bidder may be ineligible if –</p> <ul style="list-style-type: none"> <li>(a) he is declared bankrupt or, in the case of company or firm, insolvent;</li> <li>(b) payments in favor of the Bidder is suspended in accordance with the judgment of a court of law other than a judgment declaring bankruptcy and resulting (in accordance with the national laws) in the total or partial loss of the right to administer and dispose of its property;</li> <li>(c) legal proceedings are instituted against such Bidder involving an order suspending payments and which may result, in accordance with the national laws, in a declaration of bankruptcy or in any other situation entailing the total or partial loss of the right to administer and dispose of the property;</li> <li>(d) the Bidder is convicted, by a final judgment, of any offence involving professional conduct;</li> </ul>

		<p>(e) the Bidder is blacklisted and hence debarred due to involvement in corrupt and fraudulent practices, or performance failure or due to breach of bid securing declaration.</p> <p>(f) The firm, supplier and contractor is blacklisted or debarred by a foreign country, international organization, or other foreign institutions for the period defined by them.</p>
	3.9.	Bidders shall provide to the Procuring Agency evidence of their eligibility, proof of compliance with the necessary legal requirements to carry out the contract effectively.
	3.10.	Bidders shall provide such evidence of their continued eligibility to the satisfaction of the Procuring Agency, as the Procuring Agency shall reasonably request.
	3.11.	Bidders shall submit proposals relating to the nature, conditions and modalities of sub-contracting wherever the sub-contracting of any elements of the contract amounting to the more than ten (10) percent of the Bid price is envisaged.
<b>4. Eligible Information Systems</b>	4.1.	<p>For the purposes of these Bidding Documents, the Information System means all:</p> <p>a) the required information technologies, including all information processing and communications-related hardware, software, supplies, and consumable items that the Supplier is required to supply and install under the Contract, plus all associated documentation, and all other materials and goods to be supplied, installed, integrated, and made operational (collectively called “the Goods” in some clauses of the ITB); and</p> <p>b) the related software development, transportation, insurance, installation, customization, integration, commissioning, training, technical support, maintenance, repair, and other services necessary for proper operation of the Information System to be provided by the selected Bidder and as specified in the Contract.</p>
	4.2.	All Information System made up of goods and services to be supplied under the contract shall have their origin in eligible source countries, and all expenditures made under the contract will be limited to the supply and installation information systems. For purpose of this Bid, ineligible countries are stated in the section-4 titled as “Eligible Countries”.
	4.3.	For purposes of this Clause, “origin” means the place where the goods and services making Information System are produced in or supplied from. An Information System is deemed to be produced in a certain country when, in the territory of that country, through software development, manufacturing, or substantial or major assembly or integration of components, a commercially recognized product result that is substantially different in basic characteristic or in purpose or utility from its component.
	4.4.	The nationality of the supplier that supplies and install the Information System shall not determine the origin of the goods.

	4.5.	To establish the eligibility of the Goods and Services making Information System, Bidders shall fill the country-of-origin declarations included in the Form of Bid.
	4.6.	If so required in the <b>BDS</b> , the Bidder shall demonstrate that it has been duly authorized for the supply and installation of Information System in Pakistan (or in respective country in case of procurement by the Pakistani Missions abroad), the Information System indicated in its Bid.
<b>5. One Bid per Bidder</b>	5.1.	A bidder shall submit only one Bid, in the same bidding process, either individually as a Bidder or as a member in a joint venture or any similar arrangement.
	5.2.	No bidder can be a sub-contractor while submitting a Bid individually or as a member of a joint venture in the same Bidding process.
	5.3.	A person or a firm cannot be a sub-contractor with more than one bidder in the same bidding process.
<b>6. Cost of Bidding</b>	6.1.	The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the Procuring Agency shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

## B. BIDDING DOCUMENTS

<b>7. Contents of Bidding Documents</b>	7.1.	The Contents of the Bidding Documents listed below should be read in conjunction with any addenda issued in accordance with ITB 9.2 include: <b>Section I</b> -Invitation to Bids <b>Section II</b> Instructions to Bidders (ITBs) <b>Section III</b> Bid Data Sheet (BDS) <b>Section IV</b> Eligible Countries <b>Section V</b> Technical Specifications, Schedule of Requirements <b>Section VI</b> Forms – Bid <b>Section VII</b> General Conditions of Contract (GCC) <b>Section VIII</b> Special Conditions of Contract (SCC) <b>Section IX</b> Contract Forms
	7.2.	The number of copies to be completed and returned with the Bid is specified in the <b>BDS</b> .
	7.3.	The Procuring Agency is not responsible for the completeness of the Bidding Documents and their addenda, if they were not obtained directly from the Procuring Agency or the signed pdf version from downloaded from the website of the Procuring Agency. However, Procuring Agency shall place both the pdf and same editable version to facilitate the bidder for filling the forms.
	7.4.	The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all the information required in the Bidding Documents will be at the Bidder's risk and may result in the rejection of his Bid.

<b>8. Clarification of Bidding Documents, Pre-Bid Meeting and Site Visit</b>	8.1.	A prospective Bidder requiring any clarification of the Bidding Documents may notify the Procuring Agency in writing or in electronic form that provides record of the content of communication at the Procuring Agency's address indicated in the <b>BDS</b> .
	8.2.	The Procuring Agency will within three (3) working days after receiving the request for clarification, respond in writing or in electronic form to any request for clarification provided that such request is received not later than three (03) days prior to the deadline for the submission of Bids as prescribed in <b>ITB 23.1</b> . However, this clause shall not apply in case of alternate methods of Procurement.
	8.3.	Copies of the Procuring Agency's response will be forwarded to all identified Prospective Bidders through an identified source of communication, including a description of the inquiry, but without identifying its source. In case of downloading of the Bidding Documents from the website of PA, the response of all such queries will also be available on the same link available at the website.
	8.4.	Should the Procuring Agency deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under <b>ITB 9</b> .
	8.5.	If indicated <b>in the BDS</b> , the Bidder's designated representative is invited at the Bidder's cost to attend a pre-Bid meeting at the place, date and time mentioned <b>in the BDS</b> . During this pre-Bid meeting, prospective Bidders may request clarification of the schedule of requirement, the Evaluation Criteria or any other aspects of the Bidding Documents.
	8.6.	Minutes of the pre-Bid meeting, if applicable, including the text of the questions asked by Bidders, including those during the meeting (without identifying the source) and the responses given, together with any responses prepared after the meeting will be transmitted promptly to all prospective Bidders who have obtained the Bidding Documents. Any modification to the Bidding Documents that may become necessary as a result of the pre-Bid meeting shall be made by the Procuring Agency exclusively through the use of an Addendum pursuant to <b>ITB 9</b> . Non-attendance at the pre-Bid meeting will not be a cause for disqualification of a Bidder.
	8.7.	The Bidder may wish to visit and examine the site or sites of the Information System and obtain for itself, at its own responsibility and risk, all information that may be necessary for preparing the bid and entering into the Contract. The costs of visiting the site or sites shall be at the Bidder's own expense.
	8.8.	The Procuring Agency will arrange for the Bidder and any of its personnel or agents to gain access to the relevant site or sites, provided that the Bidder gives the Procuring Agency adequate notice of a proposed visit of at least seven (07) days. Alternatively, the Procuring Agency may organize a site visit or visits concurrently with the pre-

		bid meeting, as specified in the BDS for ITB Clause 8.5. Failure of a Bidder to make a site visit will not be a cause for its disqualification
	8.9.	No site visits shall be arranged or scheduled after the deadline for the submission of the Bids and prior to the award of Contract.

<b>24. Late Bids</b>	24.1.	The Procuring Agency shall not consider for evaluation any Bid that arrives after the deadline for submission of Bids, in accordance with <b>ITB 23</b> .
	24.2.	Any Bid received by the Procuring Agency after the deadline for submission of Bids shall be declared late, recorded, rejected and returned unopened to the Bidder.
<b>25. Withdrawal, Substitution, and Modification of Bids</b>	25.1.	A Bidder may withdraw, substitute, or modify its bid after submission, provided that written notice of the withdrawal, substitution, or modification is received by the Procuring Agency prior to the deadline prescribed for bid submission. All notices must be duly signed by an authorized representative and shall include a copy of the authorization (the power of attorney).
	25.2.	The Bidder modification, substitution or withdrawal notice shall be prepared, sealed, marked, and dispatched in accordance with the provisions of ITB Clauses 21 and 22 with the outer and inner envelopes additionally marked “MODIFICATION”, “SUBSTITUTION” OR “WITHDRAWAL” as appropriate. The notice may also be sent by electronic, telex and facsimile, but followed by a signed confirmation copy, postmarked no later than the deadline for submission of Bids.

## E. OPENING AND EVALUATION OF BIDS

No bid withdrawal shall be permitted unless the corresponding Withdrawal Notice contains a valid authorization to request the withdrawal and is read out at bid opening.

	26.3.	Second, outer envelopes marked “SUBSTITUTION” shall be opened. The inner envelopes containing the Substitution Bid shall be exchanged for the corresponding Original Bid being substituted, which is to be returned to the Bidder unopened. No envelope shall be substituted unless the corresponding Substitution Notice contains a valid authorization to request the substitution and is read out and recorded at bid opening.
	26.4.	Next, outer envelopes marked “MODIFICATION” shall be opened. No Technical Proposal and/or Financial Proposal shall be modified unless the corresponding Modification Notice contains a valid authorization to request the modification and is read out and recorded at the opening of the Bids. Any Modification shall be read out along with the Original Bid except in case of Single Stage Two Envelope Procedure where only the Technical Proposal, both Original as well as Modification, are to be opened, read out, and recorded at the opening. Financial Proposal, both Original and Modification, will remain unopened till the prescribed financial bid opening date.
	26.5.	Other envelopes holding the Bids shall be opened one at a time, in case of Single Stage One Envelope Procedure, the Bidders names, the Bid prices, the total amount of each Bid and of any alternative Bid (if alternatives have been requested or permitted), any discounts, the presence or absence of Bid Security, Bid Securing Declaration and such other details as the Procuring Agency may consider appropriate, will be announced by the Procurement Evaluation Committee.
	26.6.	In case of Single Stage Two Envelope Procedure, the Procuring Agency will open the Technical Proposals in public at the address, date and time specified in the <b>BDS</b> in the presence of Bidders’ designated representatives who choose to attend and other parties with a legitimate interest in the Bid proceedings. The Financial Proposals will remain unopened and will be held in custody of the Procuring Agency until the specified time of their opening.
	26.7.	The envelopes holding the Technical Proposals shall be opened one at a time, and the following read out and recorded: (a) the name of the Bidder; (b) whether there is a modification or substitution; (c) the presence of a Bid Security, if required; and (d) Any other details as the Procuring Agency may consider appropriate.
	26.8.	Bids not opened and not read out at the Bid opening shall not be considered further for evaluation, irrespective of the circumstances. In particular, any discount offered by a Bidder which is not read out at Bid opening shall not be considered further.
	26.9.	Bidders are advised to send in a representative with the knowledge of the content of the Bid who shall verify the information read out from the submitted documents. Failure to send a representative or to point out any un-read information by the sent Bidder’s representative shall indemnify the Procuring Agency against any claim or failure to read out the correct information contained in the Bidder’s Bid.

	26.10.	No Bid will be rejected at the time of Bid opening except for late Bids which will be returned unopened to the Bidder, pursuant to <b>ITB 24</b> .
	26.11.	The Procuring Agency shall prepare minutes of the Bid opening. The record of the Bid opening shall include, as a minimum: the name of the Bidder and whether or not there is a withdrawal, substitution or modification, the Bid price if applicable, including any discounts and alternative offers and the presence or absence of a Bid Security or Bid Securing Declaration.
	26.12.	The Bidders' representatives who are present shall be requested to sign on the attendance sheet. The omission of a Bidder's signature on the record shall not invalidate the contents and affect the record. A copy of the record shall be distributed to all the Bidders.
	26.13.	A copy of the minutes of the Bid opening shall be furnished to individual Bidders upon request.
	26.14.	In case of Single Stage Two Envelop Bidding Procedure, after the evaluation and approval of technical proposal the procuring agency, shall at a time within the bid validity period, publically open the financial proposals of the technically accepted bids only. The financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders subject to redress of the grievances from all tiers of grievances.
<b>27. Confidentiality</b>	27.1.	Information relating to the examination, clarification, evaluation and comparison of Bids and recommendation of contract award shall not be disclosed to Bidders or any other persons not officially concerned with such process until the time of the announcement of the respective evaluation report.
	27.2.	Any effort by a Bidder to influence the Procuring Agency processing of Bids or award decisions may result in the rejection of its Bid.
	27.3.	Notwithstanding <b>ITB 27.2</b> from the time of Bid opening to the time of contract award, if any Bidder wishes to contact the Procuring Agency on any matter related to the Bidding process, it should do so in writing or in electronic forms that provides record of the content of communication.
<b>28. Clarification of Bids</b>	28.1.	To assist in the examination, evaluation and comparison of Bids of the Bidders, the Procuring Agency may, ask any Bidder for a clarification. Any clarification submitted by a Bidder that is not in response to a request by the Procuring Agency shall not be considered.
	28.2.	The request for clarification and the response shall be in writing or in electronic forms that provide record of the content of communication. In case of Single Stage Two Envelope Procedure, no change in the prices or substance of the Bid shall be sought, offered, or permitted, whereas in case of Single Stage One Envelope Procedure, only the correction of arithmetic errors discovered by the Procuring Agency in the evaluation of Bids should be sought in accordance with <b>ITB 31</b> .
	28.3.	The alteration or modification in THE BID which in any affect the following parameters will be considered as a change in the substance of a bid:

	28.4.	From the time of Bid opening to the time of Contract award if any Bidder wishes to contact the Procuring Agency on any matter related to the Bid it should do so in writing or in electronic forms that provide record of the content of communication.
<b>29. 	29.4.	The Procuring Agency may waive off any minor informality, nonconformity, or irregularity in a Bid which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of any Bidder.

		<p><b><i>Explanation:</i></b> <i>A minor informality, non-conformity or irregularity is one that is merely a matter of form and not of substance. It also pertains to some immaterial defect in a Bid or variation of a bid from the exact requirements of the invitation that can be corrected or waived without being prejudicial to other bidders. The comparison shall be between the EXW price of the goods offered from within Pakistan, such price to include all costs, as well as duties and taxes paid or payable on components and raw material incorporated or to be incorporated in the goods, and named port of destination, border point, or named place of destination) in accordance with applicable INCOTERM in the price of the goods offered from outside Pakistan.

*(e) Spare parts and after sales service facilities in Pakistan*

*(g) Performance and productivity of the equipment.*

- (i) Bidders shall state the guaranteed performance or efficiency in response to the Technical Specification. For each drop in the performance or efficiency below the norm of 100, an adjustment for an amount specified in the **BDS** will be added to the Bid Price, representing the capitalized cost of additional operating costs over the life of the plant, using the methodology specified in the **BDS** or in the Technical Specifications.

- (ii) Goods offered shall have a minimum productivity specified under the relevant provision in the Technical Specifications to be considered responsive. Evaluation shall be based on the cost per unit of the actual productivity of goods offered in the Bid, and adjustment will be added

## B. TECHNICAL REQUIREMENTS

After meeting the requirements of eligibility, qualification and substantial responsiveness, the bid must be in compliance with all the mandatory (technical) specifications/requirements as per requisite quality threshold given below and, in the Form, T13 Technical Compliance.

### 1. Scope of Project and Requirements:

State Bank of Pakistan seeks proposals for the Supply, Installation, Integration, Maintenance & Technical Support of UPS Systems for DR Data Centre Hyderabad Site as per attached specifications.

The overall Scope of the project includes following deliverables.

Supply, installation, testing and commissioning of new UPS systems in UPS Rooms of DR Site Hyderabad:

- Modular UPS systems, Minimum capacity 60KW (N+1), Scalable to 120KW.
- Input & Output circuit breakers of required capacity to be supplied & installed in existing power panels.
- Power cables and accessories to connect UPS with Input and Output power panels.
- Battery Circuit Breaker (BCB) or any other accessory required to integrate new UPS with our existing battery cabinets having VRLA batteries (12V 65Ah, 2x40 blocks) to be connected in dual/redundant string configuration with each UPS.
- Successful testing and commissioning of UPS systems on dummy load to demonstrate the compliance with technical specifications and requirements.
- Integration of UPS systems with existing electrical system, transfer of load to new UPS setup and integration with centralized monitoring & management system (Schneider DCIM-Data Centre Expert) and BMS of the Site.
- Warranty, maintenance & technical support services as defined in SLA (Service Level Agreement).
- Onsite Operations Training to SBP staff on proposed UPS Systems.
- Dismantling/decommissioning of existing 4 x 60KVA UPS systems and associated & cables and its shifting to designated storage facility of the Site.

The bidder shall carefully go through BOQ, detailed technical Specifications and requirements, site conditions to determine complete requirement and to propose complete integrated solution. The bidder should also perform comprehensive site survey to get familiarized with site conditions and to determine the need of any additional component for the integration of new UPS systems with existing setup. Any additional component required to complete the solution as per site requirements shall be included by the bidder in its technical proposal and its cost should be covered in overall bid price.

#### 1.1 Delivery:

Delivery will be considered accomplished when all the supplies under this procurement are delivered at SBP DR Site Hyderabad and verified by the engineer in charge in accordance with the contract terms and conditions.

#### 1.2 Installation

Installation will be considered accomplished when the existing UPS has been dismantled, removed from site and new UPS systems and associated accessories are put in place and electrically, mechanically connected and ready for integration & configuration with existing electrical setup.

### **1.3 Integration & Testing**

Integration means that new UPS systems /solution has been connected to the existing SBP electrical setup and operational after testing on dummy load as per the technical requirements. This also includes installation of input and output circuit breakers of appropriate type & ratings in existing power panels of the Bank.

### **1.4 Operational Acceptance:**

Operational Acceptance means that the UPS systems, other accessories and software has been installed, configured, integrated, made operational and successfully tested in accordance with the standard procedure provided by the OEM and agreed with the client. At least 4-weeks of smooth operations in Purchaser's site under load is pre-requisite for achieving operational acceptance.

During the project until the operational acceptance of the last installation is signed off, the UPS solution should remain covered under maintenance and support services (as per SLA), without any additional cost to the Purchaser.

### **1.5 Training & Documentation:**

The supplier will provide formal hands-on operations training of proposed UPS systems to the SBP officers at Site.

The supplier will provide all necessary installation, technical, troubleshooting, maintenance and preventive maintenance manuals and documentation, CDs etc.

### **1.6 Safety, Security & Discipline:**

The staff and labors of the supplier should be well equipped with the safety gears while working in SBP during the period of the contract.

During the project implementation if anything is damaged by the Supplier then the selected Supplier will have to repair or replace the damaged item in all respect pertaining to civil, electrical, office furniture etc.

The existing channels may be used for cabling, if required the Supplier will provide & install with the same quality & color matching with the existing of site. The work will be performed at weekends / holidays subject to the prior permissions from Internal Bank Security Department.

The UPS replacement activity shall be planned in a phased manner to ensure the continuity of UPS power to critical systems of Data Center and the UPS replacement activity at one site/Room shall be performed & completed at a weekend.

The supplier must adhere to the rules, discipline and practices of SBP, during the entire course of project

## **2. Technical Specifications:**

### **2.1 Modular Uninterruptible Power Supply System**

This section specifies the engineering, supply, delivery to site, installation, testing, commissioning and maintenance of 60KW (N+1) Scalable to 120KW Modular UPS System where N is required power capacity of each UPS and +1 is redundant power module. switchgears, accessories to comply the detailed technical specifications and requirements.

- A. The UPS system shall consist of rectifier/battery charger, inverter, monitoring & control module, static bypass transfer switch, synchronizing devices, protective devices, maintenance bypass switch, filter circuits, and accessories that will automatically maintain the continuity of electrical power to load within specified tolerances, without interruption upon failure or deterioration of the normal power supply. Continuity of electric power to the load shall be maintained during the power failure period with the inverter from energy stored in batteries, or until restoration of the normal power supply as required to meet the requirement.
- B. The UPS systems shall have hot/live swappable power modules enabling to replace the faulty power module easily during operations at any time at site.
- C. The factory acceptance test (FAT) shall be detailed and performed to ensure that all features of the equipment are functioning properly and that the equipment site test will be accomplished without any major problems. FAT report shall be submitted to SBP for review and record.

The factory acceptance test shall include the following as a minimum:

- 1. Full load (N Load) capacity test. Any of the redundant module can be removed during the test to verify the N+1 capacity.
- 2. Frequency and voltage limits over the whole range of load.
- 3. Overload voltage and short circuit protection.
- 4. Voltage and frequency regulation during sudden load application.
- 5. Overload performance.
- 6. Instrument calibration.
- 7. Output tests while power being supplied from batteries only.
- 8. Battery charging and discharging test.
- 9. Battery low voltage disconnect test.

## 2.2 System Operation

- A. The UPS system shall generally include its basic and supporting equipment for the monitoring, control and protection of the system, including input and output AC filters, electronic AC line conditioner, AC and DC input and output circuit breakers, converter, inverter, static bypass switch and maintenance bypass switch.
- B. Under normal conditions, power from the mains shall be supplied to the rectifier/charger. The rectifier/charger shall convert the incoming AC power to DC power which is fed into the inverter and battery. The inverter shall convert the DC power to AC power, which is then supplied to the load through the static transfer switch. As long as, the inverter is supplied with DC, it shall supply AC to the load.
- C. Upon failure of the mains, the battery shall maintain the flow of DC to the inverter unit and the inverter unit shall continue to supply the load without interruption. Upon restoration of mains supply or when the generator supply is available, input power for the inverter unit and for the re-charging of the batteries shall automatically be supplied from the rectifier/charger output without interruption. If the battery is exhausted before the availability of the mains or generator supply, the UPS system shall shut down automatically.
- D. The static transfer switch shall normally connect the inverter output power to the load. If the inverter malfunctions, the static switch shall automatically transfer the load to the bypass source without interruption of the power supply to the load.
- E. During periods when the UPS system is being serviced, the maintenance bypass transfer switch shall be operated to transfer the load to the bypass source without interruptions.

- F. The UPS system shall include a built-in or external mechanical manual maintenance bypass system. This system shall be designed to isolate the UPS power modules and other components while continuing to supply power to the load from the bypass AC source and shall be sized to supply the full load.

### **2.3 Major Components, Design and Features**

- A. The UPS shall be designed so to permit access to modules and assemblies. The placement of parts, test points and terminals shall be such that they are accessible for maintenance without the removal of any adjacent module or assembly.
- B. The UPS system shall be provided with sufficient built-in diagnostic aids to facilitate troubleshooting, maintenance and circuit calibration. Each circuit module of the UPS system shall be accompanied by suitable indicators and test points allowing the current status of each module to be monitored as required. The UPS system shall be equipped with an event recorder so that critical data or status can be made available for analyzing when necessary.
- C. The UPS system shall be constructed in heavy duty metallic enclosures, manufactured for floor mounting/free standing. The UPS shall be structurally adequate and have casters and provisions for hoisting, jacking and forklift handling.
- D. The individual UPS and battery cabinets shall be capable of being arranged butted side-by-side. Wire runs shall be protected in a manner to separate power and control wiring. Provisions shall be made in the cabinet to permit installation of input, output and inter-cabinet cabling, using raceway or conduit.
- E. The UPS cabinets shall be painted /powder coated as per best industry standard.
- F. Adequate forced air cooling by suitably rated blowers shall be installed to ensure that all components are operated within their environmental ratings. The power supply of blowers shall be from the UPS system and treated as part of the critical load. Spare blowers should be provided. All blowers/fans shall be equipped with sensors to report an alarm in case fan failure.
- G. The rectifier & Bypass unit shall be provided with an input molded case circuit breaker. The circuit breaker shall be of the frame size and trip rating to supply full rated current to the critical load and recharge the drained battery at the same time.
- H. The rectifier/battery charger with necessary protections and have float and boost charging features as per requirement of batteries.

### **2.4 Inverter**

- A. The load shall be protected against overvoltage resulting from a loss of voltage regulation at the output of the inverters.
- B. Each inverter (and the corresponding rectifier and charger) shall shut down automatically when the DC voltage reaches the minimum voltage specified by the battery manufacturer.
- C. In the event of an overload exceeding system capacity (AC bypass absence), each inverter shall be equipped with an automatic shutdown system to protect its power circuits. A short-circuit load shall provoke the static shutdown of each inverter without fuse destruction.
- D. The inverter shall have a fault sensing device to activate the static transfer switch for removal of the inverter output from the load, without affecting it to an extent outside the limits as stated in this Specification.

### **2.5 Battery Circuit Breaker/Fuse**

- A. The UPS system shall be provided with a battery circuit breaker. When open, the battery shall be completely isolated from the rectifier / charger and from the inverter.
- B. The UPS system shall automatically be disconnected from the batteries by opening the circuit breaker when the discharge limit of volts per cell/module is reached, or when signaled by other control functions. The circuit breaker may also be manually operated during servicing of the batteries.

## **2.6 System Bypass Switches**

### **A. Maintenance Bypass Switch**

The UPS shall be provided with matching mechanical built-in or external bypass switch to manually bypass the UPS system for maintenance and service purposes. Load transfer to and from the bypass source shall be a “make-before-break” type switching such that disturbances seen by the load during a bypass shall not be greater than that specified in this Specification.

### **B. Static Bypass Switch**

A static bypass switch shall be equipped to provide uninterrupted transfer of the load to the bypass source automatically when a malfunction or overload occurs in the UPS system. The transfer shall be performed on “make-before-break” basis such that the static bypass switch is closed before the static interrupter and/or the output circuit breaker is tripped open. The static bypass switch shall preferably be paralleled with a circuit breaker which is activated together with the static switch and subsequently taking over from the static switch. If the transfer of load to bypass source is the result of an overload, when the overload is removed the load shall be re-transferred back to the inverter automatically. A selection switch shall be provided for manual transfer as well.

## **2.7 Storage Battery**

Four existing battery cabinets (available & operational at site), each containing 40 VRLA battery blocks (12V, 65Ah), will be integrated with the new UPS systems. The Contractor shall connect two battery cabinets / strings to each UPS unit. While each cabinet includes an existing DC circuit breaker for string isolation, the Contractor must supply and install a main DC circuit breaker with cabling infrastructure at each UPS to parallel / combine the two strings. The configuration must ensure that if one string fails or requires maintenance, the UPS continues to support the load without interruption using the remaining string at a reduced backup time.

## **2.8 Ups Controller**

The UPS system shall be fitted with an integral control and indication panel. The control and indication panel of the system control cabinet shall include all the necessary instrumentation, alarms and indicators showing the operation of the UPS system.

## **2.9 Instrumentation**

The UPS shall be provided with the capability of measuring the parameter indicated below. All meters shall have an accuracy of at least  $\pm 2\%$  (or as specified in the specs) of full scale or as per standard specification:

1. Input voltage and current of each phase.
2. DC battery charge / discharge current.

3. DC battery voltage.
4. UPS output voltage and current of each phase.
5. Bypass source input voltage and current of each phase and
6. Frequency of UPS output and bypass source.

## **2.10 Alarm & Indications**

The following separate alarms shall be provided for effective monitoring of the UPS system operation, with audible and visual alarms:

1. Input under/over voltage
2. Over-temperature shutdown
3. Blown fuse
4. Rectifier failure
5. Breaker open/close
6. Discharging/on battery operation
7. Battery low voltage
8. Output under-voltage
9. Output over-voltage
10. Over-temperature shutdown
11. Blown fuse/breaker trip
12. Overload
13. Overload shutdown
14. Transfer to bypass inhibited
15. Re-transfer to inverter inhibited
16. Load on bypass
17. Earth fault
18. Output breaker open
19. Ambient over temperature
20. Fan failure

## **2.11 Control**

The following system-level control functions shall be provided:

1. UPS / bypass transfer / re-transfer.
2. Battery test.
3. Emergency shutdowns push button / function
4. AC output voltage adjustment/configuration.
5. Bypass voltage limit adjustment

## **2.12 Emergency Shutdown**

Local emergency shutdown provisions shall be provided. Activation of the local emergency shutdown switch shall cause the module input, output and battery circuit breakers to open, completely isolating the UPS system from all sources of power.

## **2.13 UPS Management and Communication**

UPS-system operation shall be facilitated by a user interface on each of the modular UPS units, comprising:

- Graphical LCD display
- Control buttons

- Status indications

### **a. Graphical display**

This shall enable display of installation parameters, configuration, operating status and alarms and indication of operator instructions for switching operations (e.g. bypass). It shall be capable of supervising a given modular UPS unit

### **b. Display of measurements**

It shall be possible to display the following measurements of the modular UPS units for the entire system:

- Inverter Status
- Rectifier Status
- Battery Status
- Load on battery power
- Load on UPS

### **c. Log of time-stamped events**

This function shall store in memory and make available, for automatic or manually initiated recall, time-stamped logs of all important status changes, faults and malfunctions, complete with an analysis and display of troubleshooting procedures.

### **d. Communications**

The UPS system shall be designed to enable the extension of communications, without system shutdown, to the following types of cards that may be installed on each modular UPS unit:

RS485/Ethernet

UPS should have SNMP Module, capable of supplying information via a standard web browser without connection to a server,

## **2.14 Equipment Earthing**

All cabinet(s) shall be solidly bonded to the electrical earth provided in accordance with BS7430 using adequate section of cable.

## **2.15 Testing And Commissioning**

- A. The Contractor shall supply all tools, devices and equipment needed to complete the test. Site test requiring a load bank shall be performed as requested by the SBP Engineer. The load bank shall be furnished by the Contractor.
- B. Start-up and Site Test

- E. Simulation tests to simulate all alarms and faults.
- F. System bypass, mains failure simulation test.
- G. Full load test to verify the UPS capacity/rating and battery operations.
- H. Other tests as recommended by OEM

## **2.16 Technical Compliance of Required UPS System**

## C. Service Level Agreement (SLA)

8. Supplier will be responsible for fixing the cyber security vulnerabilities in the equipment software/firmware as per the best international practices during the warranty and SLA period without an additional cost to the client.
9. Supplier will acknowledge SBP representative call during and after standard business hours for logging of support case and communicate the case/incident ID to SBP by telephone/email
10. The supplier will maintain critical spare parts / power module to address the emergency faults calls at facility. The list of critical spares will be mutually agreed by the two parties. SBP representative reserves the right to inspect inventory of spares at any given point during SLA and warranty period
11. The supplier will perform preventive maintenance on quarterly basis or as recommended by OEM in accordance with the check list of routines and activity, mutually agreed by the two parties.
12. SBP will determine the incident severity level.
13. During warranty and maintenance support SLA period, the supplier will have to provide support services as per the required SLA as mentioned below.

### **3. Availability Requirement & Incident Severity Matrix:**

This section defines the Service Level requirements, classification of incidents, and means of reporting, and expectations for availability and response times in relation to Hardware and Software components of the equipment that are to be maintained and supported by the Supplier.

1. OEM backed warranty & Service support Package (24x7x365) with parts.
2. Guaranteed response, 7 days/week, and 24 hours/day.
3. Includes four Annual Preventative Maintenance Service scheduled by the customer at an agreed time.
4. Performed by trained Engineers of OEM or Engineers OEM Authorized Service Provider.
5. Includes all parts and labor for preventive and corrective actions 24 hours a day 7 days a week.
6. In case of any conflict or deficiency in OEM support package as compared to SLA requirements of the contract, then terms and conditions of contract will prevail over the OEM support package. In such case the local partner shall bridge the gap to meet the SLA requirements at no additional cost to the Bank.

#### **3.1 Incident Classification and Required Response & Recovery time**

Following table outlines the Incident Classification System including required response and recovery time during warranty and SLA period:

##### **A. Severity 1 (RED)**

Any of the Modular UPS is "completely down" and load is not protected due to a very critical failure, or more than one power modules are faulty in one UPS unit or fault in Input/output circuit breaker or maintenance bypass panel affecting the performance of UPS to supply conditioned power to load. **(Response time 02 hrs and Recovery within 06 hrs)**

Note: If more than one power modules were faulty and N capacity was compromised, then if service provider restores the N capacity (60KW) within 06 hrs. Then the incident class will automatically shift to Severity 2 (Orange) for recovery of +1 (redundant power module) of UPS.

### **B. Severity 2 (ORANGE)**

Any redundant component/redundant power module of UPS is failed only, N capacity of UPS is intact, and UPS is providing power to load in a compromised manner i.e. without redundancy **(Response time 04 hrs and recovery within 48 hrs).**

### **C. Severity 3 (YELLOW)**

Operational performance of the UPS system is partially compromised while the UPS is operational on load e.g. any indication / early warning / non-critical error on display or log, abnormal noise, replacement of fan or any other deteriorated component is required, that do not require urgent attention, or any non-urgent information / technical assistance is required by the customer. There is little or no effect on SBP business operations. **(Response time 01 day and Recovery within 5 days).**

### **D. Response Time**

The time from logging a support call until the bidder technical team start working on solving the problem.

### **E. Recovery Time**

The time from call logging until the problem resolution and from one severity level to next severity level.

### **F. Business Hours:**

Standard: 9:00AM – 6:00PM, Monday through Friday excluding holidays.

Extended: 8:00AM – 8:00PM, Monday through Friday excluding holidays.

Note: Above mentioned standard and extended business hours are not applicable for Severity-1 (Red) and Severity-2 (Orange) category incidents as those incident need 24x7 guaranteed response.

## **3.2 Site Access**

The supplier will be essentially required to provide necessary CNIC of the Project Manager, Engineers, Technicians, labors and other logistic resources etc. working within the Procuring Agency's site during the contract period.

The supplier must adhere to the rules, discipline and practices of SBP during the entire course of project.

## **4. Call Logging**

1. The Supplier shall provide details about Help Desk or Customer Support contact information including details about Call Logging Procedure to ensure recording, monitoring and reporting of support calls.
2. For Red and Orange categories faults, the complaint can be lodged anytime during 24 x 7, which will be handled according to severity categories, however for Yellow category the standard business hours shall be observed.
3. Supplier should provide call logging through telephone in terms of Support Levels and Escalation Procedures that should be mapped to the Severity of the incidents and should also provide telephone number which will be used after Standard Business Hours.
4. Supplier shall provide details about structure of Technical Support in terms of Support Levels and Escalation Procedures that should be mapped to the Severity of the incidents.
5. The Supplier shall provide onsite support, maintenance, replacement and update of BIOS, firmware, and all associated software supplied as part of solution covered under this agreement. The Supplier will provide latest version of firmware/software on Customer's request for up gradation purpose free of cost. In case of bug in Software/firmware Supplier will provide required patch and will perform patching, testing and verifying the changes with the coordination of the Supplier (if requested). Upgrade to Latest Version or patch fixing shall be free for the Customer.
6. Supplier shall submit all incident reports and quarterly summary reports for any support period as and when required.
7. Supplier shall perform all dispatch functions, including keeping the Customer informed about the status and eventual completion of replacements or repairs.
8. RED incidents should be given an escalated level of commitment from Supplier. For RED incidents, Supplier shall ask their Support Professionals to work non-standard hours, reassign critical resources from other activities, and/or ensure a Support Professional to work round-the-clock until a problem is fully resolved.
9. A problem that initially starts with a severity RED situation may be classified at severity ORANGE upon implementing a workaround. When a permanent solution is found and implemented, the problem might be reclassified to severity YELLOW for monitoring before it is closed. However, reclassification of severity shall be accepted and signed off by the Customer.
10. If same fault re-occurs within 48 hours, the original call will be reopened with the same log number, and the Recovery Time will continue from the time that original call was re-opened. In case the faulty item or unit is required to be sent overseas for repair or replacement services then Supplier will send the faulty equipment and deliver the replacement or repaired equipment to the Customer site at its own cost to overseas for repair and replacement.

## **5. Coverage**

Complete UPS systems (excluding batteries), associated switchgear and accessories supplied and installed under this contract are covered in in this contract. During warranty and SLA period all faulty equipment/Infrastructure components shall be repaired/replaced by the supplier at no additional cost and the replaced equipment shall become property of the bank.

In the event of a battery fault, the contractor shall notify the SBP. Upon receipt of a replacement battery from SBP, the contractor shall perform the replacement / installation without additional cost.
