Tenders will be opened at **12:00** hours on **08-07-2026** (Wednesday) and must reach POF Bids Centre through Air mail / courier before 11:30 hrs. The tenders received late will not be entertained. The bids "By hand" must be received in the Bid center 30 minutes before the time of Bid opening. You may witness

the opening of the tender if so desired. If a representative is deputed, he should bring a **letter of authority**. Venue of Tender Opening is **POFs Bid Centre (Room No. 02), Behind Rabta Hall, POF, Wah Cantt.**

#### 1. **SUBMISSION OF TENDER**

1.1 Please quote as per following single stage two envelope methods. You are required to quote in two parts: -

a) **Part I "Technical Offer"**: It should exclusively give technical details and literatures/brochures of the offered **Zinc PHO Solution**; validity date; delivery schedule; and signed undertaking given on the schedule to this Tender Enquiry. Technical Offer is must be accompanied by a fix bid money of **Rs. 1,500,000/-** & Tender Fee of Rs 2,500/-. Advance sample (**80 Ltr's**) must be provided with technical offer for functional trail & Lab Test.

**Note:** it must not indicate price, costs etc.

b) **Part II "Commercial Offer"**: It should indicate the commercial terms e.g. price, terms of payment, mode of payment, mode of supply. Each part should be placed in a separate sealed cover. The envelopes should be inscribed with: Part I "Technical Quotation without Price" and Part II "Commercial Quotation with Price".

1.2 Only one tender should be included in one envelope. The outside of the envelope should be inscribed with: -

## **2.0 GENERAL INSTRUCTIONS:**

- 2.1 The quotation must remain valid for at least 90 days from the date of opening of tenders.
- 2.2 The quotation should hold good for any reduced / short closure or enhanced quantity without notice.
- 2.3 Conditional offers or alternative offers are likely to be ignored.
- 2.4 Quotations should be based on "Free Delivery" at Packages Factory, (Adjacent to POF Barrier 01), Sanjwal Cantt.
- 2.5 The suppliers registered with Sales Tax Deptt are only eligible to participate in the T.E. The competitive supplier shall have to furnish Sales Tax Invoice and Professional Tax Clearance Certificate.
- 2.6 The supplier responsible to provide PHO in its own canes (on returnable basis). Each supply contains 20 ltr's per cane (Transparent Cane indication level reading / Marking).

## **3.0 TENDER FEE:**

The Tender must be accompanied by a non-refundable fee of rupees Rs. 2,500/- by means of a Pay Order in favour of CEO / MD Wah Industries Ltd., Quaid Avenue, Wah Cantt. The Tender fee must be made part of technical offer.

## **4.0 BID MONEY:**


- 4.1 Bid Money of **Rs. 1,500,000/-** should accompany in the shape of CDR/Pay Order issued from a Scheduled Bank drawn in favour of CEO / MD Wah Industries Ltd. Bid Money must be made part of technical offer. Tenders received without Bid Money will be rejected.
- 4.2 Bid Money of the unsuccessful bidder will be returned as soon as the scrutiny of the tenders is completed. Bid Money of the successful offers will be retained until the contract is finalized. Bid Money will be forfeited in case the quotation is withdrawn before the expiry of its validity date.

## **5.0 PERFORMANCE GUARANTEE:**

- 5.1 The successful bidder will provide Performance Guarantee at the rate of 10% of the contract value in favour of CEO / MD Wah Industries Ltd, Wah Cantt. The Performance Guarantee will be furnished in the form of Pay Order from any scheduled bank. The Performance Guarantee will be submitted prior to the placement of Contract and the same will be returned on **successful completion of contract**. In case the firm fails to supply the contracted store / contractual obligations, PG will be forfeited.

## **6.0 INSPECTION:**

- 6.1 The inspection of store will be carried out by QC-PF / Q.A / IDA (I of A). Getting BR Material cleared from IDA Lab/Q.A Lab/QC-PF is sole contractor's responsibility. In case of Deviation, the PR (Price Reduction) amount, as recommended by Inspection Authority, will be deducted from contractor.

**7.0 ACCEPTANCE OF OFFERS:**

The Right to accept or reject any offer in full or in part, without assigning any reason is hereby reserved.

**8.0 FAILURE TO SUPPLY THE STORES:**

Performance Guarantee @ 10% of the total value of contract will be submitted prior to the placement of contract. The Performance Guarantee will be returned on satisfactory completion of the contract. In case of failure of the supply, the Performance Guarantee will be forfeited.

**9.0 LIQUIDATED DAMAGES:**

All the deliveries must be completed by the specified date. If the failure to deliver the stores within the scheduled time should have arisen from "Force Majeure", which the purchaser may admit as reasonable ground for further time, He will allow such additional time as he may consider to have been required by the circumstances of the case. Otherwise, he will be entitled, at his discretion, to cancel the contract; and / or, claim liquidated damages up to 2% but not less than 1% of the contract price of the items and their quantities for each & every month or part of a month, beyond the specified delivery date, during which these may Not be delivered, subject to a maximum of 15% of the total contract value; or, to purchase from elsewhere, the unsupplied stores at the risk and cost of the supplier.

**10.0 MATERIAL / STORES:**

The material / stores shall conform to the specifications as laid down in the schedule to Tender Enquiry.

**11.0 WARRANTY / GUARANTEE:**

The stores shall be supplied on Warranty / Guarantee subject to Inspection at PF. Rejected stores will be removed and replaced with the acceptable store by the supplier at his own expenses within specified time.

**12.0 PAYMENT:**

100% payment will be made after receipt & acceptance of store at Packages Factory. Part payment against part supply is allowed.
